WHEREAS, Government Code Section 54985 authorizes the County of El Dorado Board of Supervisors to adopt new fees, fee levels and charges pursuant to the fee authority listed; and

WHEREAS, this resolution further determines fees are based on the responsible party's ability to pay and subject to being waived or reduced as ordered by the Court; and

WHEREAS, on October 11, 2017 the Governor signed Senate Bill 190, amending sections of the Govt, Penal and Welfare and

WHEREAS, be it further resolved, that upon approval, Resolution XXX-2016XXXX shall supersede and replace any and all previous resolutions pertaining to these specific fees, excluding Resolution #251-2006 which shall remain unaffected; and

WHEREAS this resolution does not increase any fees previously adopted.
