Dear Supervisor Briggs,

I live in Amador County and work in El Dorado County. I do not own a "Speeder", but I am a fan of Railroads and Railroading. I am especially enthusiastic about "historic Railroads". I am also a bicycle enthusiast, and ride both a road bike and a mountain bike. We have an opportunity to preserve a part of our history. To remove the rails of the Placerville Branch to make a bike trail would be a crime. Very few bicyclists are ever going to ride up that long hot grade. I know I will not. There will be some who will ride down it at full speed. I admit, that would be fun, but not nearly as fun as riding a train on those historic rails. If the rails are pulled, they are pulled forever. That would forever eliminate the possibility of having a tourist train that runs between Folsom (or Sacramento) and Placerville. The draw of such a tourist train would be incredible, and a real boost to the economy of El Dorado County. I realize that we do not have the funding to do it now. But we are not going to be in a recession forever. I would have no problems with a dual use trail built along side the rails. But I completely object to pulling the rails, just so they can be sold for scrap, to help fund the paving of a trail that few will ever use. To sacrifice this historic resource for the economic benefit of a few elitists would be a shame, and I will fight it in every way I can.

I will not be able to attend your meeting, so please make my comments part of the Public Record.

Again, if the rails are pulled, they are gone forever.
