Understand your county's status

Every county in California is assigned to a tier based on its rate of new cases and positivity. At a minimum, counties must remain in a tier for at least 3 weeks before moving forward. Data is reviewed weekly and tiers are updated on Tuesdays. To move forward, a county must meet the next tier's criteria for two consecutive weeks. If a county's metrics worsen for two consecutive weeks, it will be assigned a more restrictive tier. Public health officials are constantly monitoring data and can step in if necessary.

Do you have any clarity from our State as to when we can move tiers based on our data? According to the below website, when I click on our county it shows a 3.6 new case rate per 100K and 3.6% positivity rate, which is in the range of "moderate" (orange) but they classify us as "substantial" (red)? https://covid19.ca.gov/safer-economy/

Also below lists the EDC positivity rate at 3.1% as of end of day Friday and the dashboard there seems to put EDC in moderate range for cases prior 14 days? https://edcgov.us/Government/hhsa/covid-19-cases
