

**AGREEMENT FOR SERVICES #194-S1511
AMENDMENT II**

Therapeutic Counseling and Substance Abuse Treatment Services

This Amendment II to that Agreement for Services #194-S1511, is made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Community Recovery Resources, a California Corporation, duly qualified to conduct business in the State of California, whose principal place of business is 180 Sierra College Drive, Grass Valley, CA 95945 (Mailing: PO Box 6028, Auburn, CA 95604) and whose Agent for Service of Process is Warren A Daniels, 180, Sierra College Drive, Grass Valley, CA 95945 (hereinafter referred to as "Contractor").

RECITALS

WHEREAS, Contractor has been engaged by County to provide therapeutic counseling and substance abuse treatment services for the Health and Human Services Agency (HHS) in accordance with Agreement for Services #194-S1511, dated November 17, 2014, and Amendment I to that Agreement, dated July 19, 2016; incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to amend **Article II – Term** and **Article IV – Maximum Contractual Obligation**.

NOW THEREFORE, the parties do hereby agree that Agreement for Services #194-S1511 shall be amended a second time as follows:

Articles II and IV are amended in their entirety to read as follows:

ARTICLE II

Term: This Agreement shall become effective when fully executed by all parties hereto and shall cover the period of November 17, 2014 through November 16, 2018, unless terminated earlier pursuant to the provisions contained herein this Agreement under the Article(s) titled "Default, Termination, and Cancellation" or "Fiscal Considerations."

ARTICLE IV

Maximum Contractual Obligation: The maximum contractual obligation under this Agreement shall not exceed \$277,712.00 for all of the stated services during the term of this Agreement.

ARTICLE XLVI

Entire Agreement: This Agreement for Services #194-S1511 and the documents referred to herein or exhibits hereto are the entire Agreement between the parties and they incorporate or supersede all prior written or oral agreements or understandings.

Except as herein amended, all other parts and sections of that Agreement #194-S1511 shall remain unchanged and in full force and effect.
