Subj: Reconsideration of Commissioner Linda Grimoldi's Appointment

Dear Supervisors:

At your last Board meeting you pointedly asked Linda Grimoldi if she intentionally omitted her membership in the group Boots on the Ground Cali ("BOTGC"), including her role as an administrator/moderator of that group's Facebook page. You also pointedly remarked that commissioners are a direct reflection of the Board.

Ms. Grimoldi was not forthcoming with you, despite admonitions from four Supervisors prior to her appointment. Therefore, you should seriously reconsider your nomination based on her lack of disclosure when faced with questions regarding her veracity. I am documenting those issues for your review, but for now please be aware Ms. Grimoldi did not disclose the following:

- Her friendship with Aaron Bate, a BOTGC founder, and his relationships with the extremist Three Percenters militia, Proud Boys, and neo-Nazi supporters.
- Sharing Facebook posts with at least two Proud Boys, and with Chelsea Knight, whose neo-Nazi profile was shared with you.
- Using Nazi symbols to disparage the Democratic Party and Democrats in general.
- That a fellow BOTGC administrator/moderator, Alicia Peterson, had or has relationships with the extremist Three Percenters militia, Proud Boys, neo-Nazi supporters, and persons who participated in the attack on the U.S. Capitol.
- Remarkably, Ms. Grimoldi did not disavow her BOTGC ties to extremist individuals and groups.

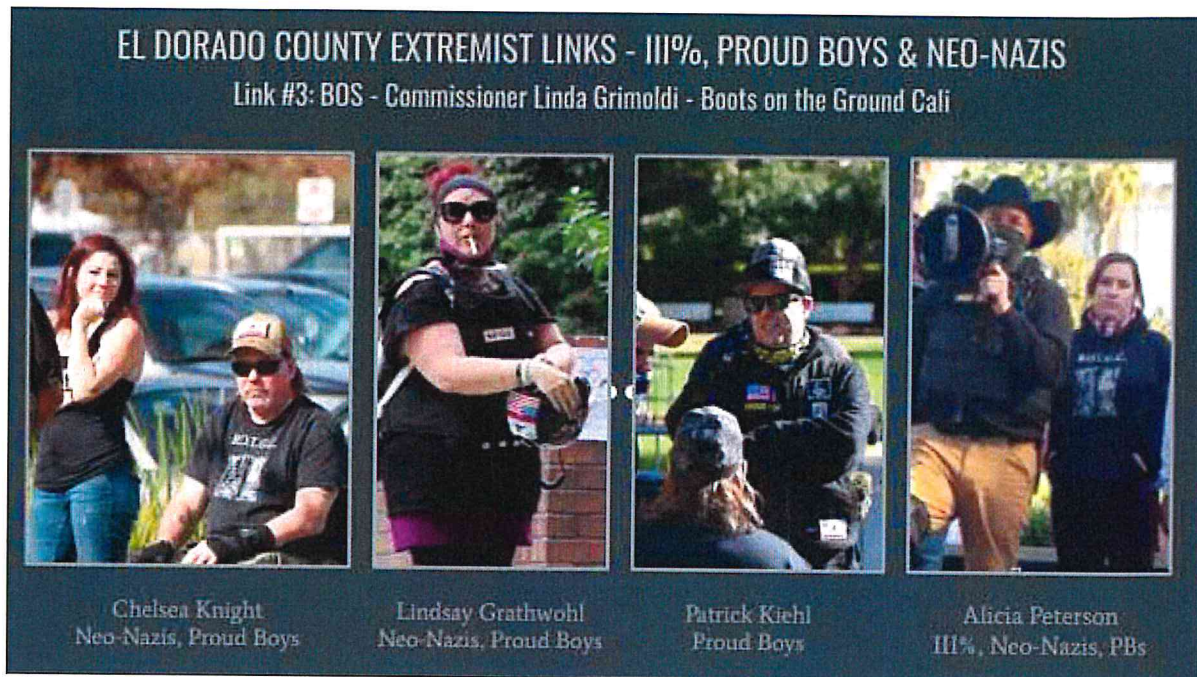

Private First Class Paul F. Ticksman, U. S. M. C. died on January 4, 1943, in a Japanese war prison. He had given his life according to the code, when his brother, Lieutenant James P. Ticksman, was killed July 14, 1943, in a plane crash near Ephrata, Washington.

The report of the death of their son Paul was received last week and by Mr and Mrs. Charles J

son Paul was received last week and by Mr and Mrs. Charles J Ticksman of Diamond Springs in a telegram from the commandant of the United States Marine Corps, which reported the date of his death and included an expression of condolence and sympathy. The message said that information concerning interment has not been obtained.

Paul F. Ticksman was born at Seattle, Wash., in 1921. He was about 22 years of age at the time of his death. He attended University High School in Oakland and transferred to El Dorado County High School, where he was graduated in June of 1939.

School officials, informed during the week of his death, remembered him as a good student and as one of the graduates whom they would remember for his sincerity and interest in his studies and the example of good citizenship which he

In regard to the additions made March 22nd to BOS Agenda Item #34, on Page 3 under Good Governance #7 states:

#7) - Create and maintain a positive governance culture for all employees, co-workers, colleagues, **board-appointed commissions and the public** by operating in an environment of **trust, respect and professional demeanor at all times**.

My public comments and inquiries pertaining to this agenda item are attached for the public record, but rather than the BOS responding directly to my inquiries **as required by law**, Don Ashton flippantly remarked:

There has been a lot of discussion about the allegations of Mr. White. There are confidential personnel matters; we're not going to respond to the emails and inquiries about that. I can tell you that Supervisor Turnboo worked directly with our Human Resources director and appropriate action was taken. And I'll leave it at that.

First of all, my specific inquiries below were NOT pertaining to “confidential personnel matters.” Don Ashton acted outside the bounds of his authority by inappropriately diverting the issues pertaining to Good Governance. Then he minimized my factual complaints concerning Todd White’s **unprofessional and disrespectful** conduct which in reality is **hate speech, discrimination, and retaliation**.

Secondly, Comrade Parlin had the audacity to “shush” me when I lawfully demanded a public response. In fact, the entire BOS violated the Brown Act by refusing to respond about their hypocritical lack of adherence to EDC Core Values and Good Governance policies. Note *U.S. v. Tweel*, - “Silence can only be equated with **fraud** where there is a legal or moral duty to speak or where an inquiry left unanswered would be **intentionally misleading**.” ***This is information the public has a right to know about their government representatives, just as much as the public has to know the truth about the Hunter Biden Laptop scandal.***

Lastly, as a former Human Resources professional I can assure you that Joseph Carruesco is indeed obligated by law--**at the very least**--to acknowledge and document all correspondence directed to the HR department, then take action to ensure the illicit conduct is remediated. Joseph Carruesco is remiss in his fiduciary responsibilities, because it is obvious no action was ever taken by HR with regard to **Sheriff D’Agostini, Don Ashton, Lori Parlin, George Turnboo, and especially Todd White** who continues to unlawfully deprive me of public services and benefits of Taxpayers membership aided and abetted by **Commissioner Andy Nevis**. Read that as **fraud**.

This is not the first time these public servants--and others--abused the public trust and violated their oaths of office. No wonder EDC has had a revolving door of 15 HR Directors in the past 20 years! The greater mystery is why has “California’s oldest newspaper” failed to provide honest journalism on the subject of EDC corruption??

It was Frederick Bastiat who said, “When law and morality contradict each other the citizen has the cruel alternative of either losing his sense of morality or losing his respect for the law.”

With regard to the hypocrisy of this agenda item, I will describe a small sample of factual situations and then pose a few salient questions that I expect the board to publicly address as required by law:

During a 2011 quarterly meeting with **Sheriff D’Agostini** he said, “*You need a new Board [of Supervisors.] All of them. Hold their feet to the fire. Mine too; I work for you.*” I quoted the Sheriff during a 2013 BOS meeting. That’s when he ordered IT to block my ability to correspond electronically with all EDSO staff and refused to meet any longer. When it was discovered that case reports were being falsified and I was denied access to those reports as required by law, I filed Citizens Complaints of Officer Misconduct, but was denied due process. In retaliation for exposing EDSO corruption, the Sheriff rescinded my previously approved CCW permit. He later threatened me with a restraining order and ordered me out of “his building” for the lawful exercise of my Constitutional rights.

Similarly in 2018 **Don Ashton** distributed a county-wide email ordering IT to restrict my ability to communicate electronically with county staff, thus depriving me of my First Amendment Rights. This has all been publicly documented in the form of unrebutted affidavits which stand as truth before any court in America.

Please explain how the **Sheriff’s** and **Don Ashton’s** unconstitutional actions align with the County Mission to “provide efficient, courteous, and effective service and infrastructure for safety, protection, and well-being of our residents, businesses and visitors?”

Lori Parlin has refused to respond to constituent concerns. Most notably during a Mt. Murphy Bridge Zoom meeting held in this room, Lori publicly mocked me in front of members of my community and censored my on-line questions. She has also abused the public trust through her violations of the Brown Act and her oaths of office.

Most recently you heard how **Todd White** called me a “bitch, a trashy whore” and other unspeakable profanities in the presence of George Turnboo upon exiting the Taxpayers meeting. **HR Director Joseph Carrusco** and **Supervisor Turnboo** obviously condone such behavior because there has been no response to my demand to remove Todd from office as required by law.

For the public record, please explain what the **forementioned public servants** say about your adherence to Good Governance, specifically the Core Values of **Accountability** - Responsible for our decisions and **behavior**. . . answerable to our citizens; **Integrity** - Doing what is right legally and morally at all times regardless of whether or not someone is watching; and **Service Excellence**.

Mr. Carruesco,

During last week's BOS Open Forum you were made aware of "smoking-gun" evidence of Todd White's unlawful actions against me. (Refer to the attached documents which were entered into the public record.) **Todd White's egregious actions are an abysmal disgrace to El Dorado County, the Boys & Girls Club of Northern Sierra, the Taxpayers Association, the Republican Central Committee, and especially Park Community Church and the Christian community.**

In defiance of the Brown Act and their oaths of office, Supervisor Turnboo and Chairman Parlin refused to publicly respond to my inquiry as required under section 54954.2(a) of the Brown Act: *"I'm asking you again, as your sister-in-Christ, what specific action are you going to take pursuant to your oaths to remove Todd from office, or will it have to be resolved in court? This is not a rhetorical question. As per section 54954.2(a) of the Brown Act, I demand your public answer now, while I'm at the podium."*

By refusing to respond, George Turnboo and Lori Parlin harmed me by conspiring with county staff to suppress my inherent right of free speech, preventing and/or restricting my access to government employees, **and depriving me of public information and/or public services necessary to assist my efforts for redress of grievances—all lawful actions on my part that fall under the protections of the First Amendment.** Thus George and Lori, as individuals, will also be held personally accountable and liable for any and all harm they have inflicted upon me and my inherent, constitutionally secured rights by your failure to take remedial action, to wit:

"Personal involvement in deprivation of constitutional rights is prerequisite to award of damages, but defendant may be personally involved in constitutional deprivation by direct participation, failure to remedy wrongs after learning about it, creation of a policy or custom under which unconstitutional practices occur or gross negligence in managing subordinates who cause violation." (Gallegos v. Haggerty, N.D. of New York, 689 F. Supp. 93 (1988). [Emphasis added])

Then during this week's BOS updates, George Turnboo obliquely mentioned meetings with the **Water Agency, Chief Administrative Officer, County Counsel, and Planning Commissioners.** It is reasonable to deduce that those meetings were to discuss the issues I brought to the public's attention during the March 8th BOS meeting involving Todd White, Planning Commissioners Andy Nevis and Kris Payne, and CAO Don Ashton. As you and Chief Counsel David Livingston are well aware, those individuals, amongst others, have all received similar affidavits substantiating their criminal roles in Conspiracy Against Rights and Deprivation of Rights Under Color of Law. (See Title 18, Sections 241 and 242.)

I have a duty and right to demand that you, Mr. Carruesco, take immediate action to remove Todd White from office. Demand is also made to take appropriate disciplinary action against Supervisors Turnboo and Parlin, as well as Andy Nevis, Kris Payne, and CAO Don Ashton. **This is not optional.** As the Director of Human Resources, and pursuant to your own oaths of office, you have a moral, ethical and legal obligation to follow

through with these demands. The same applies to Chief Counsel David Livingston. Your failure to abide by the Supreme Law of the Land makes you complicit and liable for aiding and abetting government corruption.

If you have any questions, please don't hesitate to contact me. I look forward to your prompt response and confirmation of compliance with these demands to take immediate action against the aforementioned public servants.

Todd: **You bitch!...Go fuck yourself!...You're a trashy whore!**

Melody: Oh my gosh, did you hear that?! Your **public servant**, supposedly a deacon in his church, just called me a whore, a piece of trash and a bitch! What are you going to do about it?

George Turnboo: Well, I'm going to straighten him out. It's not right.

George Turnboo has had knowledge of Todd's unlawful actions for quite some time, therefore he is complicit and liable for failure to take remedial action. The County is required by law to take disciplinary action, especially in the case of Todd White, and remove him from office.

The Founders used Exodus 18:20-21 as a guide to establish our Republic, "And you shall teach them ordinances and laws, and shall show them the way wherein they must walk, and the work that they must do. Moreover you shall provide out of all the people able men, such as fear God, men of truth, hating covetousness; and place such over them..."

This is the first meeting I've attended this year, but I have been watching videos of Comrade Parlin as she rudely cuts off speakers in mid-sentence as if they are contestants on the Gong Show. Not only is she in violation of the Brown Act Rights of the Public, she consistently demonstrates the hypocrisy of the EDC Core Values before you. Lori's censorship and abuse of the public trust is no different than Canada's President Trudeau, but more on that later.

Let me begin by saying I'm a third generation evangelical. I've been privileged to host conferences at my home in Coloma for artists, international speakers, politicians, missionaries and evangelists from all over the globe. My family members are the founders of Calvary Chapel, the largest non-denominational church in America. Prior to retiring I worked for Sacramento legislators, most notably Barbara Alby who was the author of California's Megan's Law, and I still remain actively involved in Capitol ministries.

Yesterday Registrar of Voters Bill O'Neill was the guest speaker at the Taxpayers meeting. Afterwards I had a brief encounter with Todd White and George Turnboo. I can play the 60-second audio for you right now, but I don't think it will come across clearly, so I'll submit the transcript into the public record. Here is the edited essence:

Melody Lane: Hey George, you need to speak with Todd to make sure he is giving me agendas for these meetings. Again, I have a right, just as any other member or public employee does to get the agendas and schedule of speakers. Todd, this involves you.

Todd: **You bitch!...Go fuck yourself!...You're a trashy whore!**

Melody: Oh my gosh, did you hear that?! Your **public servant**, supposedly a deacon in his church, just called me a whore, a piece of trash and a bitch! What are you going to do about it?

George: Well, I'm going to straighten him out. It's not right.

It's significant that Todd is the Secretary of the Taxpayers Association and Secretary of the Republican Central Committee. The RCC holds their monthly meetings at Park Community Church where Todd claims to be a deacon. George, your ex-wife has described you as a "**fake pastor**" who plagiarizes other pastor's sermons. You've stood me up, lied to me, and refused to respond to constituent concerns in violation of your oaths of office and EDC Core Values, in particular **Accountability, Integrity and Service Excellence**. The Bible and the Constitution have a lot to say about that. It's all outlined in **[these affidavits]** addressed to you and Todd White. Unless you take immediate remedial action, you are aiding and abetting government corruption.

I'm asking you again, as your sister-in-Christ, what specific action are you going to take pursuant to your oaths to remove Todd from office, or will it have to be resolved in court? This is not a rhetorical question. As per section 54954.2(a) of the Brown Act, I demand **your** public answer **now**, while I'm at the podium.

(Silence)

George, the law is before you.

(Silence)

Again, it's right there before you. You know what the law says; you know what your moral, ethical and legal responsibility is.

(Silence)

I'm waiting.

(Silence)

Let me put it this way: I am an American Citizen claiming all of my constitutionally secured inherent rights and guaranteed due process of law. Since I am based in constitutional authority, any effort on your part to stop me from speaking or for your walking out of this room, and/or forcibly removing me from this room conclusively demonstrates by your own actions to be in opposition to the Constitutions, that you have shown yourselves, all of you, to be domestic enemies & are unfit to serve in any official capacity, pursuant to the self-executing Sections 3 & 4 of the 14th Amendment, at minimum.

(Silence)

Again George—not County Counsel, not Don Ashton—your response is required by law. Your failure to respond just proves again that you are in violation of your oaths of office and you are guilty of treason. All of you. You are a disgrace to your community.

Madam Clerk: Please enter these documents into the public record. You have not heard the end of this.
