My wife and I have owned our home in Shingle Springs for 13 years. She is a local public school teacher, and I own a small business in Placerville. Both our children attended Ponderosa High. This is our home. My folks have lived here for 30 years, and we moved here 14 years ago after numerous visits to my parents: we appreciated the rural quality of life.

I am very concerned to learn that you and 3 other County Supervisors have voted for a terrible rezoning of the area around Ponderosa and 50. I feel rezoning these parcels for intense commercial use would be a disaster for the neighborhood and homeowners, not to mention the massive impact on traffic in the area.

I and many others are watching very carefully about what is decided and by whom. It is probably not too early to state that any elected official against this misguided decision would have many, many life-long supporters. The converse is also true: any Supervisor voting for such a disruptive, traumatic zoning policy might well face recall petitions and well funded opposition at the next election. Hopefully the voters and residents wishes are carried out, not just the owner of a large parcel and out of town developers.
