# Securitas Technology Corporation

### FIRST AMENDMENT TO AGREEMENT FOR SERVICES #8292

THIS FIRST AMENDMENT to that Agreement for Services #8292 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Securitas Technology Corporation, a Delaware corporation duly qualified to conduct business in the State of California, whose principal place of business is 3800 Tabs Drive, Uniontown, Ohio 44685, and whose local address is 910 Riverside Parkway, Suite 80, Sacramento, California 95605 (hereinafter referred to as "Contractor").

#### RECITALS

WHEREAS, Contractor has been engaged by County to assist its Chief Administrative Office, Facilities Division, in performing services necessary to update the control system at the El Dorado County Juvenile Treatment Center located at 1041 Al Tahoe Boulevard, South Lake Tahoe, California 96150, pursuant to Agreement for Services #8292, dated June 18, 2024, incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

WHEREAS, Sourcewell is a State of Minnesota local government agency and service cooperative created under the laws of the State of Minnesota (Minnesota Statutes Section 123A.21) that offers cooperative procurement solutions to government entities. Participation is open to federal, state/province, and municipal governmental entities, higher education, K-12 education, nonprofit, tribal government, and other public entities located in the United States and Canada. Sourcewell issued Request for Proposals #030421 on January 14, 2021, for Facility Security Systems, Equipment, and Software with Related Services:

WHEREAS, Pursuant to the competitive bidding and selection process by Sourcewell, Sourcewell and Contractor executed Contract #030421-SCS on April 23, 2021, for Facility Security Systems, Equipment, and Software with Related Services. Sourcewell Contract #030421-SCS expired April 22, 2025;

WHEREAS, Sourcewell issued Request for Proposals #121024 on October 22, 2024, for Facility Security Systems, Equipment, and Software with Related Services;

WHEREAS, Pursuant to the competitive bidding and selection process by Sourcewell, Sourcewell and Contractor executed Contract #121024-SCS on March 19, 2025 (hereinafter, the "Sourcewell Contract"), for Facility Security Systems, Equipment, and Software with Related Services;

WHEREAS, the Sourcewell Contract expressly authorizes other participating public agencies to "piggyback" off and use the Sourcewell Contract for Facility Security Systems, Equipment, and Software with Related Services. County is a participating member of Sourcewell (County's membership number is 101387) and is authorized to utilize the cooperative purchasing contracts available to Sourcewell members;

WHEREAS, the terms and conditions of the Sourcewell Contract, incorporated herein by reference, and this Agreement shall govern the equipment and services required under this Agreement, and parties agree that the terms and conditions of the Sourcewell Contract shall prevail in the event of a conflict;

WHEREAS, the parties hereto desire to amend the Agreement to extend the expiration date for six (6) additional months, amending ARTICLE II, Term;

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Contractor mutually agree to amend the terms of the Agreement in this First Amendment to Agreement for Services #8292 on the following terms and conditions:

I. ARTICLE II, Term, of the Agreement is amended in its entirety to read as follows:

#### ARTICLE II

**Term:** This Agreement shall become effective from the date specified in the official Notice to Proceed with the Work, which shall be attached to this Agreement as an addendum and shall become part of this Agreement, and shall expire on January 31, 2026, as amended.

Except as herein amended, all other parts and sections of Agreement for Services #8292 shall remain unchanged and in full force and effect.
