#### AMENDMENT I

This Amendment I to that Agreement for Services #316-S1611, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Mother Lode Van & Storage, Inc., a California Corporation duly qualified to conduct business in the State of California, whose principal place of business is 11255 Pyrites Way, Suite 400, Rancho Cordova, California 95670 (hereinafter referred to as "Contractor").

#### RECITALS

**WHEREAS**, Contractor has been engaged by County to provide moving services and modular furniture disassembly, inventory, removal, and reinstallation services on an "as requested" basis for the County facilities both on the East Slope and West Slope of El Dorado County, in accordance with Agreement for Services #316-S1611, dated January 26, 2016, incorporated herein and made by reference a part hereof; and

**WHEREAS**, the parties hereto have mutually agreed to increase the total amount of said Agreement by \$150,000.00.00 for a new not-to-exceed amount of \$300,000.00, hereby amending **ARTICLE III – Compensation for Services**.

**NOW THEREFORE**, the parties do hereby agree that Agreement for Services #316-S1611 shall be amended a first time as follows:

#### **ARTICLE III**

**Compensation for Services:** is amended to increase the total amount of the Agreement by \$150,000.00 for a not to exceed amount of \$300,000.00, inclusive of all Work Orders, costs and expenses.

Except as herein amended, all other parts and sections of that Agreement #316-S1611 shall remain unchanged and in full force and effect.
