PROTOCOLS FOR PUBLIC COMMENT

Public comment will be received at designated periods as called by the Commission Chair.

Individuals will have three minutes to address the Commission. Except with the consent of the Commission, individuals shall be allowed to speak to an item only once.

It is the intent of the Commission to have additional flexibility depending upon the nature of the issue. Individual Commission members may ask clarifying questions but will not engage in substantive dialogue with persons providing input to the Commission.

If a person providing input to the Commission creates a disruption by refusing to follow Commission guidelines, the Commission Chair may take the following actions:

Step 1. Request the person adhere to Commission guidelines. If the person refuses, the Commission Chair may turn off the speaker's microphone.

Step 2. If the disruption continues, the Commission Chair may order a recess of the Commission meeting.

Step 3. If the disruption continues, the Commission Chair may order the removal of the person from the Commission meeting.

C. CHAIRPERSON'S REPORT

Bob Kamrath provided the Chairperson's report. The Commission held a moment of silence to honor Supervisor John Hidahl for his support in the community.

D. GUEST SPEAKER - JOHN THOMAS, CERTIFIED TRAINER OF OLDER ADULTS

John Thomas provided a PowerPoint presentation highlighting the benefits of exercise for older adults and reviewed the common issues experienced by older adults. John also included strength training exercises and highlighted areas that are needed in everyday life such as picking up things and standing up, pulling, pushing/reaching, balancing, and carrying.

E. AAA DIRECTOR'S REPORT, QUESTIONS, AND ANSWERS

Yvette Wencke was unable to attend the meeting due to a conflicting meeting with C4A and the California Department of Aging.

Jordan Brushia provided the report for Yvette. The AAA is actively recruiting for Senior Nutrition and The Clubs Older Adult Day Services. The Supervisor for The Club in El Dorado Hills has transferred to another position and Yvette will be providing support at the El Dorado Hills site until another Supervisor is hired.

Jordan also provided an update on the Fall Prevention Program which ended on September 30, 2024. This program is being rolled into an Aging-in-Place program. Community Services Block Grant (CSBG) is being utilized to provide Transportation/Assisted Transportation to low-income individuals. Due to the expiration of additional funding grants, the FCSP respite budget has substantially been reduced and will limit the number of hours available to caregivers. A mini-series held in January. I&A continues to meet with clients on Thursdays at the Tahoe Senior Center.
