The County of El Dorado, Community Development Agency (CDA), Transportation Division, Tahoe Engineering (TE) is proposing a revision to the Subject Round 12 Southern Nevada Public Land Management Act (SNPLMA) Grant. This proposed revision is for moving the remaining funds from the close out Round 11 SNPLMA grant (11-DG-11051900-031) and adding the funds to the Round 12 SNPLMA grant through a grant augmentation. These funds will be used to supplement the budget for construction engineering & administration on the Country Club Heights Erosion Control Project (Project).
