**WHEREAS**, the El Dorado County Director of Emergency Services did proclaim the existence of a local emergency on April 12, 2006 due to conditions of extreme peril to the safety of persons and property caused by severe storms, and;

**WHEREAS**, on April 18, 2006 the El Dorado County Board of Supervisors ratified the declaration and determined that it will continue to extend the declaration until the damages that occurred can be repaired;

**WHEREAS**, the El Dorado County Board of Supervisors does find at its regularly scheduled meetings on April 25, May 9, 16, and 23, June 6, 13, 20 and 27, July 11 and 18, August 15, 22, and 29, and September 12, 19, and 26, October 3, 17, and 31, November 7, 14, 21, and December 5, 2006 that the aforesaid storm event damages continue to present conditions of peril, and that the local emergency declaration continue; and

**WHEREAS**, said conditions no longer continue to exist

**NOW, THEREFORE, BE IT RESOLVED** that said local emergency shall be terminated by the Board of Supervisors of the County of El Dorado, State of California.
