Adopted July 19, 2004



Last amended October 2017



Purpose: address the management, preservation, and conservation of natural resources and open space of the County

Summary of Revisions

- **General** – made minor amendments for readability, clarification, and updates to terminology
- **Objective 7.3.4: Drainage**
 - Added Policy 7.3.4.3 – consider future projections of flood causing storms as criterion for siting of public facilities
- **Objective 7.4.2: Identify and Protect Resources**
 - Added Policies 7.4.2.10 and 7.4.2.11 – develop a list of priority open space areas that may be included in future conservation plans or connectivity assessments
- **Objective 7.4.4: Forest, Oak Woodland, and Tree Resources**
 - Added Policies 7.4.4.5-7.4.4.12 – provide policies and strategies for forest resource management and wildfire prevention

Summary of Revisions

- **Objective 7.4.5: Equitable Access to Open Space**
 - Added Objective 7.4.5 and Policies 7.4.5.1-7.4.5.11 – encourage preservation and enhance of equitable access to natural areas and resource-based recreation
- **Objective 7.5.1: Protection of Cultural Heritage**
 - Changed Policy 7.5.1.1 – develop a Cultural Heritage Management Strategy
 - Added Policy 7.5.1.7 – encourage incorporation of significant cultural resource sites into open spaces
- **Objective 7.5.3: Recognition of Precontact and Other Historic Resources**
 - Added Policies 7.5.3.1-7.5.3.5 – recognition of precontact cultural history of public open space through educational programs and signage
- **Objective 7.6.1: Importance of Open Space**
 - Added Policy 7.6.1.5 – develop a strategy for natural resource restoration using process-based restoration techniques

Recommendation

Forward a recommendation to the Board to take the following actions:

1. Adopt the Addendum to El Dorado County's General Plan Environmental Impact Report; and
2. Approve the General Plan Conservation and Open Space Element amendment based on the Findings as presented.
