THIRD AMENDMENT TO AGREEMENT FOR SERVICES #9438

THIS THIRD AMENDMENT to that Agreement for Services #9438 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Neighborly Pest Management, Inc., a corporation duly qualified to conduct business in the State of California, whose principal place of business is 324 Riverside Avenue, Roseville, California 95678 (hereinafter referred to as "Contractor").

RECITALS

WHEREAS, County has determined that it is necessary to obtain a contractor to assist in providing glassy-winged sharpshooter delimitation services for its Department of Agriculture pursuant to Agreement for Services #9438, dated March 11, 2025, First Amendment to Agreement for Services #9438, dated May 13, 2025, and Second Amendment to Agreement for Services #9438, dated July 15, 2025, incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

WHEREAS, the parties hereto desire to amend the Agreement to increase the not-to-exceed compensation amount of the Agreement by \$1,994,000, amending **ARTICLE III, Compensation for Services**;

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Contractor mutually agree to amend the terms of the Agreement in this Third Amendment to Agreement for Services #9438 on the following terms and conditions:

- I. **ARTICLE III, Compensation for Services, paragraph 3**, of the article is amended to read as follows:

The total amount of this Agreement, as amended, shall not exceed \$4,522,000, inclusive of all Task Orders and amended Task Orders, costs, taxes, and expenses. It is understood and agreed that there is no guarantee, either expressed or implied, that this dollar amount will be authorized under this Agreement through Task Orders.

Except as herein amended, all other parts and sections of Agreement for Services #9438 shall remain unchanged and in full force and effect.
