

RESOLUTION NO. 224-2024

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

WHEREAS, the County of El Dorado Board of Supervisors is authorized to adopt new fees, and charges, and adjust the levels of existing fees and charges; and

WHEREAS, the County of El Dorado Board of Supervisors is authorized to adopt new penalties and adjust existing penalties for violations of various statutes and ordinances; and

WHEREAS, the El Dorado County Sheriff's Office has reviewed and analyzed the current Records Fee Structure, Work Program Fee Structure and Parking Penalty Structure; and

WHEREAS, the analysis of the Records Fee Structure and Work Program Fee Structure concluded that the proposed fees do not exceed the reasonable cost of providing the associated service; and

WHEREAS, sixteen (16) fees were revised to the current Records Fee Schedule; and

WHEREAS, two (2) fees were removed to the current Work/Weekender Program Fee Schedule; and

WHEREAS, five (5) fees were revised to the current Parking Penalty Schedule; and

WHEREAS, two (2) fees were added to the current Parking Penalty Schedule;

NOW, THEREFORE, BE IT RESOLVED that effective January 1, 2025, this Resolution, and the fees, fee levels, charges and penalties attached hereto as Exhibit A," Records Fee Structure", Exhibit B "Work/Weekender Program Fee Structure" and Exhibit C "Parking Penalty Structure" shall be implemented, and supersede any prior written or verbal Records fees, Work/Weekender Program fees and Parking Penalties specific to Exhibits A, B, and C, hereto.
