**RESOLUTION OF VACATION  
Abandonment of Easement #07-0009  
R/S 25/9 Tract 4, formerly Village "I", Lot C, Lot 12  
Assessor's Parcel Number 123-210-21  
Lori E. Lasecke and Brian K. Lasecke**

**WHEREAS**, the El Dorado County Board of Supervisors exercises the authority established by Section 8333 of the Streets and Highways Code, which authorizes the Board of Supervisors to summarily vacate public service easements by Resolution adopted in accordance with Section 8335 of the Streets and Highways code; and

**WHEREAS**, public utilities easements, as shown on the Village "I", Lot C final map, were irrevocably offered in perpetuity to the County of El Dorado in August of 2000 and accepted by the Board of Supervisors in October of 2000; and

**WHEREAS**, Boundary Line Adjustment #01-0031 and the subsequent Record of Survey Map 25/9 that recorded in the County of El Dorado Recorder's Office in August of 2001, relocated the common side lot line between Lot 11 and Lot 12 of Village "I", Lot C, and changed Lot 12 to Tract 4; and

**WHEREAS**, the Department of Transportation has received an application from Lori E. Lasecke and Brian K. Lasecke, owners of Tract 4, requesting that the County of El Dorado vacate public utilities easements located on the rear and side boundary lines; and

**WHEREAS**, A T & T, Comcast, El Dorado Irrigation District, and Pacific Gas & Electric have not used said easements for the purpose for which they were dedicated or acquired; and find that no present or future need exists for said easements and do not object to their vacation; and

**WHEREAS**, all other existing easements will remain; and

**WHEREAS**, the Department of Transportation has determined that said easements herein described in Exhibit "A" and depicted in Exhibit "B", and made a part hereof, have not been used for the purpose for which they were dedicated preceding the proposed vacation, and has no objection.

**NOW, THEREFORE BE IT RESOLVED**, that from and after the date this Resolution is recorded, said public utilities easements described in Exhibit "A" and depicted in Exhibit "B" are vacated and no longer constitute public utilities easements. In addition, a Certificate of Correction is hereby authorized to be signed and may be recorded by the County Surveyor.
