2020 PROPOSED SOLID WASTE COLLECTION AND MATERIAL RECOVERY FACILITY RATE INCREASES

Notice is hereby given that a public hearing will be held via Zoom at 10:00 a.m. on Tuesday, August 4, 2020, by the El Dorado County Board of Supervisors which will be held at the Board of Supervisors' Chambers, 330 Fair Lane, Building A, Placerville, California. The public hearing will consider the request by El Dorado Disposal Service to increase solid waste collection rates by 1.0% for Franchise Areas A, B, and C, as well as the Material Recovery Facility, to be effective September 1, 2020. The public hearing will also consider the request by El Dorado Disposal Service to increase solid waste collection rates by an additional 3.78% for residential services and 4.82% for commercial and roll-off services due to unforeseen circumstances related to recent market developments, for Franchise Areas A, B, and C, as well as a 3-year stepped approach to increase certain Material Recovery Facility rates, to be effective September 1, 2020. The public hearing will further consider the request by the Environmental Management Department to impose an additional 2.46% surcharge to all solid waste collection rates.
