OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

RESOLUTION DISCHARGING ACCOUNTABILITY
FOR UNPAID COUNTY DEBTS

WHEREAS, the following debts have been investigated and pursued by the Revenue Recovery Division of the Treasurer-Tax Collector's Department, or other Departments as listed, and found to be uncollectible and the likelihood of collection does not warrant further expense and administrative costs due either to the death of the debtor, bankruptcy, *unfunded State mandated programs*, or the running of applicable statutory statutes of limitations; and

WHEREAS, Government Code sections 25257 through 25259 authorize the Board of Supervisors to discharge the relevant department of accountability for debtor accounts owed to the County for the reasons stated therein; and

WHEREAS, the Board of Supervisors may make an order discharging the department, officer, or employee from further accountability and direct the County Auditor to adjust any charge against said department, officer, or employee in a like amount per Government Code section 25259.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of El Dorado County, pursuant to Government Code sections 25257 through 25259, that the Treasurer-Tax Collector and certain other County Department Heads are discharged from accountability for the attached debtor accounts and the County Auditor is directed to adjust any charge against said departments. Such discharge from accountability does not constitute a release of any person from liability for payment of any amount.
