



RESOLUTION NO. 096-2023

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

WHEREAS, in compliance with Government (Gov.) Code section 7522.56 of the Public Employees' Retirement Law, the Board of Supervisors of the County of El Dorado must provide CalPERS this certification resolution when hiring a retiree before 180 days has passed since their retirement date; and

WHEREAS, Steven McVey, (last 4 digits of SSN 4553), retired from the County of El Dorado in the position of Principal Engineering Technician, effective April 29, 2023; and

WHEREAS, Gov. Code section 7522.56 requires that post-retirement employment commence no earlier than 180 days after the retirement date, which is October 27, 2023, without this certification resolution; and

WHEREAS, the Board of Supervisors of the County of El Dorado, the County of El Dorado and Steven McVey certify, that Steven McVey has not and will not receive a Golden Handshake or any other retirement-related incentive; and

WHEREAS, the Board of Supervisors of the County of El Dorado hereby appoints Steven McVey as an extra help retired annuitant to the vacant position of Principal Engineering Technician for the County of El Dorado under Gov. Code section 21221(h), effective July 1, 2023; and

WHEREAS, the entire employment agreement, contract, or appointment document between Steven McVey and the County of El Dorado has been reviewed by this body and is attached herein; and

WHEREAS, no matters, issues, terms, or conditions related to this employment and appointment have been or will be placed on a consent calendar; and

WHEREAS, the employment shall be limited to 960 hours per fiscal year for all CalPERS employers; and

WHEREAS, the compensation paid to retirees cannot be less than the minimum nor exceed the maximum monthly base salary paid to other employees performing comparable duties, divided by 173.333 to equal the hourly rate; and

WHEREAS, the maximum base salary for this position is \$8,985.60 and the hourly equivalent is \$51.84, and the minimum base salary for this position is \$7,392.67 and the hourly equivalent is \$42.65; and

WHEREAS, the hourly rate paid to Steven McVey will be \$51.84; and

WHEREAS, Steven McVey has not and will not receive any other benefit, incentive, compensation in lieu of benefit or other form of compensation in addition to this hourly pay rate; and

NOW, THEREFORE, BE IT RESOLVED the Board of Supervisors of the County of El Dorado hereby certifies the nature of the employment of Steven McVey as described herein and that this appointment is necessary to fill the critically needed position of Principal Engineering Technician for the County of El Dorado by July 1, 2023 because this employee's retirement left the Department of Transportation (Transportation) without a person who has the extensive knowledge and experience to use Autodesk Civil 3D to complete critically needed plan sets and details for the projects in the Capital Improvement Program (CIP). This position requires the ability to train and work with technical engineering staff, as well as technical expertise in creating

contract document drawings and other graphic exhibits. The Computer Aided Design & Drafting (CADD) unit's current positions all remain vacant at this time. Extensive recruiting has been underway for over the past year to fill these vacant positions. Steven McVey has supervised and has been leading the CADD unit for years and his position is needed to continue to deliver CIP projects within grant funding timelines.
