



## RESOLUTION NO. 136-2012

### OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

**WHEREAS**, the Health and Human Services Agency (HHS) and Child Support Services (CSS) use some classifications that are created and maintained by Merit System Services (MSS); and

**WHEREAS**, MSS has revised and adopted a new Staff Services Analyst class series used by HHS and CSS, and

**WHEREAS**, the Merit classifications of Staff Services Specialist, Staff Services Analyst III, Supervising Staff Services Analyst, and Principal Staff Services Analyst are new in the series, and Staff Services Analyst I/II and Staff Services Manager have been modified, and Information Systems Supervisor is an existing Merit classification that HHS would like to adopt; and

**WHEREAS**, the County of El Dorado must assign a job classification number (JCN), designate a salary schedule, and assign a bargaining unit to each new MSS classification that is to be utilized; and

**WHEREAS**, in accordance with Section 202 of the El Dorado County Compensation Administration Resolution #227-84 applicable to represented employees, and Section 501 of the El Dorado County Salary and Benefits Resolution #323-2001, as amended, applicable to unrepresented employees, the Board of Supervisors shall by Resolution specify the number and classification of all authorized positions for each department of the County; and

**WHEREAS**, in accordance with Section 203 of the El Dorado County Compensation Administration Resolution #227-84 applicable to represented employees, and Section 601 of the El Dorado County Salary and Benefits Resolution #323-2001, as amended, applicable to unrepresented employees, the Board of Supervisors shall by Resolution establish the salary for all authorized positions within the County; and

**WHEREAS**, Resolution #062-2012 established the authorized Personnel Allocation based on the Fiscal Year 2012-2013 recommended Budget and has been subsequently amended by action of the Board; and

**WHEREAS**, the Board of Supervisors of the County of El Dorado authorizes the Director of Human Resources to make any technical corrections if needed.

**THEREFORE, BE IT RESOLVED** that the Board of Supervisors of the County of El Dorado does hereby adopt the new JCN, salary schedule and bargaining unit for the new MSS classifications as set forth below:


