ELECTRONIC LAW LIBRARY SERVICES

1. INTRODUCTION

LexisNexis, a division of Reed Elsevier Inc. has agreed to provide electronic information library services via External Hard Drive (EHD)/licenses with quarterly updates. The Contractor shall adhere to all terms and conditions as stated herein throughout the effective term of this Agreement.

2. CONTRACTOR'S RESPONSIBILITIES

The Contractor shall provide Electronic Law Library Services for the El Dorado County Sheriff's Office Jail. The Contractor shall provide electronic information and law library resources via EHD or licenses and provide quarterly updates.

3. CONTRACT TIME PERIOD

The term of this Agreement for this service category is May 1, 2015, through June 30, 2016. Ordering agencies may not execute contracts/orders beyond this date, nor shall the contract term end date of a contractor/order executed by an ordering agency, extend beyond June 30, 2016.

4. PRICING

Per MSA 5-11-99-03, Amendment 3, Attachment 15, under Distributed Media for California Correctional Facilities, the Contractor (LexisNexis) will charge \$385 per month for 2-49 authorized users to use electronic services for off-line California/Legal research content delivered on External Hard Drives, updated on a quarterly basis.

Per MSA 5-11-99-03 the contractor (LexisNexis) will charge the ordering agency (El Dorado County) the 2% DGS administrative fee. Ordering agency is responsible for applicable sales tax on delivered External Hard Drives.


