



## RESOLUTION NO. 228-2019

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

### **SOUTH TAHOE REFUSE CO., INC. SCHEDULE OF RATES FRANCHISE AREAS A and B**

**WHEREAS**, on December 2, 2014, the Board of Supervisors approved the First Amendment to the South Tahoe Refuse Franchise Agreement consolidating the American River Disposal Franchise into the South Tahoe Refuse Franchise and providing for a series of two additional 4% rate increases in the former American River Disposal franchise area, with the rate increases to be effective January 1, 2016 and January 1, 2017 (Resolution 227-2014); and

**WHEREAS**, on December 2, 2014, the Board of Supervisors also authorized a rate increase of 4% for American River Disposal, now referred to as Area B of the South Tahoe Refuse Franchise Agreement (Resolution 228-2014), and a 2.66% increase for original South Tahoe Refuse franchise area, now referred to as Area A (Resolution 209-2014), with the rate increases to be effective January 1, 2015; and

**WHEREAS**, on December 15, 2015, in accordance with the First Amendment to the South Tahoe Refuse Franchise Agreement, the Board of Supervisors authorized the first 4% rate increase for Area B to be effective January 1, 2016 (Resolution 209-2015); and

**WHEREAS**, on December 13, 2016, in accordance with the First Amendment to the South Tahoe Refuse Franchise Agreement, the Board of Supervisors authorized the second 4% rate increase for Area B to be effective January 1, 2017, after which Area B rate adjustments will be governed by the Solid Waste Rate Setting Policies and Procedures Manual (Resolution 203-2016); and

**WHEREAS**, on December 13, 2016, the Board of Supervisors also authorized a rate increase of 1.62% for Area A (Resolution 204-2016), with the rate increases to be effective January 1, 2017; and

**WHEREAS**, on December 12, 2017, the Board of Supervisors authorized a 9.34% base year rate increase for Franchise Areas A and B, with 6.26% of the increase to be effective January 1, 2018, and the remaining 3.08% of the increase, in addition to any Board approved interim year rate adjustment, to be effective January 1, 2019 (Resolution 190-2017); and

**WHEREAS**, on December 11, 2018, the Board of Supervisors authorized a 3.11% interim year rate adjustment increase for Franchise Areas A and B in addition to the remaining 3.08% increase that was deferred from the 2018 base year rate increase for a total rate increase of 6.19% to be effective January 1, 2019 (Resolution 247-2018); and

**WHEREAS**, a public hearing was held on December 17, 2019, for the purpose of adjusting solid waste collection rates for the South Tahoe Refuse Co., Inc. (South Tahoe Refuse) Franchise Areas A and B; and

**WHEREAS**, County Ordinance section 8.42.150 provides that the Board of Supervisors shall set the rates to be charged by a franchisee at such times as the Board of Supervisors deems appropriate; and

**WHEREAS**, pursuant to County Ordinance section 8.42.170, the franchisee has provided written notice to each ratepayer of the proposed adjustment in a form approved by the County of the time, date, and place of public hearing to set rates and the notice was provided at least ten but no more than sixty days before the public hearing; and

**WHEREAS**, pursuant to County Ordinance section 8.42.170, notice of the time, date, place, and purpose of the public hearing has been published in a newspaper of general circulation printed and published in the County, once each week, for two consecutive weeks prior to such hearing; and

**WHEREAS**, the South Tahoe Refuse Franchise Areas A and B solid waste collection rates shall have a 2.93% rate increase effective January 1, 2020.

**NOW, THEREFORE**, be it resolved that effective January 1, 2020, the following rates are adjusted upward by 2.93% for the collection of solid waste within the South Tahoe Refuse Franchise Areas A and B:


