Summary of DAPO MOU

- As of March 2022, Probation and DAPO have a signed MOU in place which sets the structure for parolees residing in El Dorado County to access programs and services offered by probation.
- The goal of this agreement is to reduce recidivism and increase public safety through effective community reintegration; specifically, the partnership will develop smoother transition for individuals releasing to parole and post release community supervision.
- The programs and services offered at the Community Corrections Center/Day Reporting Center, address linkage to needs such as food, clothing and shelter, behavioral health treatment needs for mental health and substance abuse.
- The number of allotted slots is twenty (20) for the duration of twelve (12) months for the current Fiscal Year 2022/2023 and 2023/2024.

PROBATION'S Roles/ Responsibilities

- Provide access to food through on-site Probation Food Pantry (partner w/ County Food Bank).
- Provide access to Housing through partnerships with County Housing Authority; including Probation operated Transitional Housing Program (The Bridge).
- Behavioral Health Services – Including Substance Use Disorder services – on site through County Health & Human Services.
- On site Cognitive Restructuring Groups (Moral Reconation Therapy – Probation led).
- Access to on-site DMV services (provided by State DMV – No Cost to County).
- Workforce Development; Probation contract with Northern CA Construction Training)
- Adult Education & Job Preparation through Probation contract with EDCOE.

CDCR/ DAPO Roles/ Responsibilities

- Provide Multifaceted interim support to parolee-clients during their linkage to long term sustainable community services.
- Comprehensive and enhanced case management services with the primary focus on linkage for community integration.
- Development of Individualized Reintegration Plans (IRP) to identify specific needs and formulates goal oriented plans to address those needs.
- Engage in pre and post release assessments and review of records in formulation of IRP as warranted.
- At initial and subsequent contacts, assess stability of basic needs, (food, clothing, shelter, mental health, medication and sobriety) and provide immediate assistance as needed.

Accessing Ancillary Services

- **IMPROVED PUBLIC SAFETY:** Often re-offense by offenders occurs shortly after release from jail or prison. With proper transition planning, programming and services available within institutions and the community, including effective case management recidivism can be reduced.
- **INCREASED EMPLOYMENT OPPORTUNITIES:** Re-Entry programs aim to lower obstacles to unemployment so that parolees and/or probation clients can receive meaningful workforce development services or find jobs once released.
- **IMPROVING HEALTH CONCERNS:** Upon release from jail or prison, there is frequently a lack of behavioral health treatment. Re-Entry programs in collaboration with projects such as the Stepping UP Initiative can ensure that the availability of proper behavioral & medical services are accessed by offenders.
- **PREVENTING HOMELESSNESS:** With pre-release planning that includes the linking and brokering of targeted wraparound services, an individual returning to the community connected to Re-Entry programs such as the CCC have a greater likelihood exiting homelessness and ending the cycle of being “high-users” within the jail.

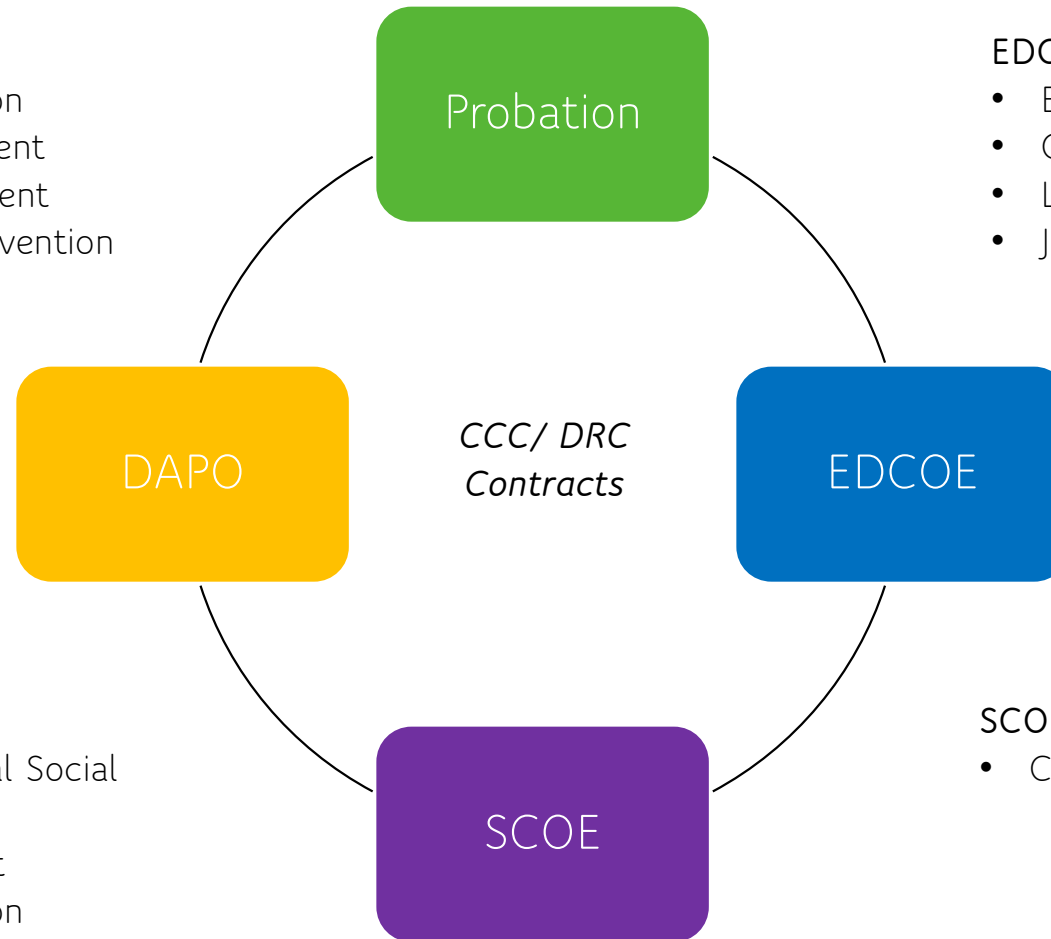

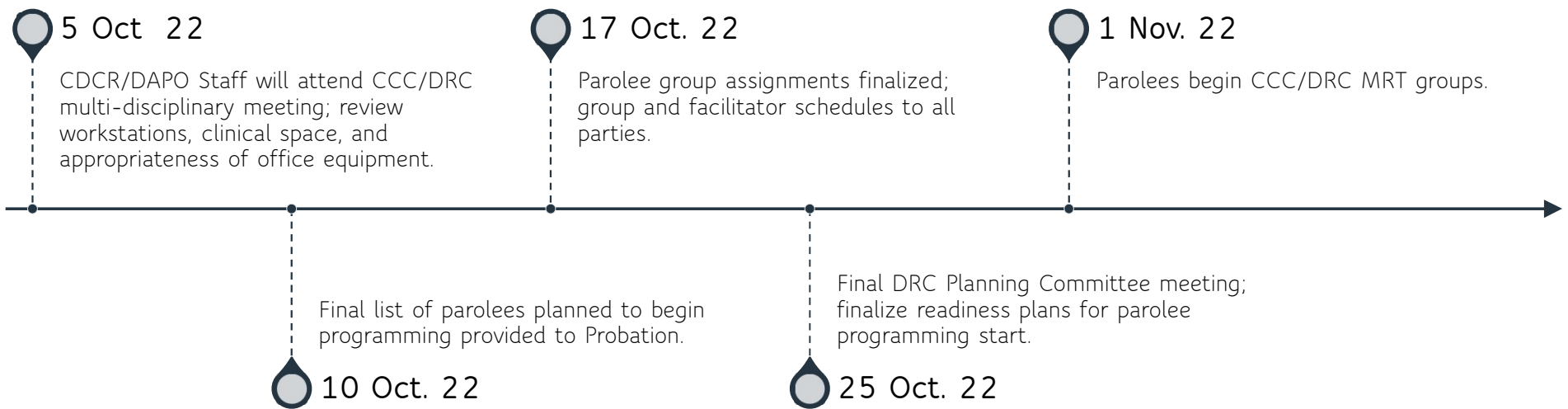
