Recommendation:

Your Board is requested to authorize the Chair to sign Amendment #5 to the software license agreement with TracNet Corporation of Pacific Grove, California.

Reason for Recommendation:

Since 1996 TracNet Corporation has provided the Sheriff's Office with software for computer-aided dispatch, in-field report writing, records management and jail management via a master software license agreement.

The Sheriff's Office has received federal funding to purchase a new Homeland Security Intelligence Database component for the in-field report writing system.

Please note that the original software license with TracNet Corporation, approved by your Board on September 24, 1996, Amendment #1 approved by your Board on June 27,2000, Amendment #2 approved by your Board on June 27, 2001, Amendment #3 approved by your Board on June 11, 2002 and Amendment #4 approved by your Board on July 1, 2003 contained non-standard liability and insurance provisions. The amendment before you does not change that situation, as has been noted by both County Counsel and Risk Management in their review of the amendment. As was the case on those five prior occasions, the Sheriff's Office recommends that your Board note the concerns raised by County Counsel and Risk Management but authorize the Chair to sign the Amendment anyway.

Fiscal impact:

None. \$20,000 is available in the Sheriff's FY 05-06 budget for this purchase. Funds are also available for the \$4800 increase to the annual maintenance service plan.

Action to be Taken Following Approval:

The Chair will sign the Amendment.
