ADMENDMENT I TO FACILITY USE AGREEMENT #208-01111 SHERIFF'S FORT JIM SATELLITE STATION

THIS AGREEMENT, made and entered into by and between the COUNTY OF EL DORADO, a political subdivision of the State of California (hereinafter referred to as "COUNTY") and the EL DORADO COUNTY FIRE PROTECTION DISTRICT, whose principal place of business is 4040 Carson Road, Camino, CA 95709 (hereinafter referred to as "DISTRICT");

WITNESSETH

WHEREAS, the COUNTY entered into an Agreement with the DISTRICT for the use of certain real property for the purpose of operating a Sheriff's Search and Rescue Station in the Placerville area, in accordance with Facility Use Agreement #208-O1111, dated August 23, 2011.

WHEREAS, the County desires to continue utilizing those portions of the PROPERTY described in the original Facility Use Agreement for the purpose of continued operation of the Sheriff's Search and Rescue program in Placerville, California; and

WHEREAS, the parties hereto mutually agree to extend the term of the agreement for one (1) additional two (2) year period herby amending Section 7; and

WHEREAS, the parties hereto mutually agree to amend Sections 7 and 10.

NOW THEREFORE, the parties do hereby agree that Facility Use Agreement #208-O1111 shall be amended a first time as follows:

- 7. The term of this Agreement, as amended, shall cover the period of March 1, 2010 through February 28, 2015, unless said term is extended, by mutual agreement in writing thirty (30) days prior to the expiration date.
- 10. **NOTICES:** Except as otherwise expressly provided by law, any and all notices or other communications required or permitted by this Agreement, shall be in writing and be deemed duly served and given when personally delivered to the party to whom it is directed or, in lieu of such personal service, when deposited in the United States mail, first-class, postage prepaid, addressed to:
