FIRST AMENDMENT TO AGREEMENT FOR SERVICES #4681

THIS FIRST AMENDMENT to that Agreement for Services #4681 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and More 4 Less Pest Control, a general partnership duly qualified to conduct business in the State of California, whose principal place of business is 1390 Broadway, Suite B-256, Placerville, California 95667 (hereinafter referred to as "Contractor");

RECITALS

WHEREAS, Contractor has been engaged by County to provide routine, on-call, and emergency pest control services for the Chief Administrative Office, Facilities Division pursuant to Agreement for Services #4681, dated March 25, 2020, incorporated herein and made by reference a part hereof (herein after referred to as "Agreement");

WHEREAS, the parties hereto desire to amend the Agreement to increase the not-to-exceed compensation amount of the Agreement by \$25,000 for an updated not-to-exceed amount of \$95,000, amending **ARTICLE III, Compensation for Services**;

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Contractor mutually agree to amend the terms of the Agreement in this First Amendment to Agreement on the following terms and conditions:

- I. **ARTICLE III, Compensation for Services**, the third paragraph is amended in its entirety to read as follows:

The total amount of this Agreement shall not exceed \$95,000, inclusive of all Work Orders, costs, taxes, and expenses. It is understood and agreed that there is no guarantee, either expressed or implied that this dollar amount will be authorized under this Agreement through Work Orders.

Except as herein amended, all other parts and sections of Agreement for Services #4681, shall remain unchanged and in full force and effect.
