Dear Judge Kingsbury:

This will confirm that the Court has agreed to permit the County Department of Child Support Services (DCSS) to occupy approximately 500 square feet of space that is currently occupied by the Court in the El Dorado Center building in South Lake Tahoe. This will permit DCSS to maintain its presence in the Tahoe area, which benefits the public as well as the Court. The space to be occupied is in the general clerk's office area, and does not include any courtroom, chambers or jury room space, although DCSS can use the jury room for occasional meetings if it does not interfere with Court use.

In return, DCSS will give to the Court a filing system that it no longer needs. DCSS will move it and install it at the location designated by the Court in the Johnson building. The process that the County must follow is to place the filing system on the surplus list, and the Court must then "claim" it. I understand that DCSS has already placed the filing system on the surplus list and has advised Court staff on how to claim it, so that process should be working already. Please have your staff coordinate with Child Support about the timing and details of the move and installation.

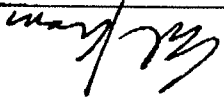
The County is grateful for the Court's cooperation. This agreement will not prejudice any party's position concerning the occupancy allocation under SB 1732.

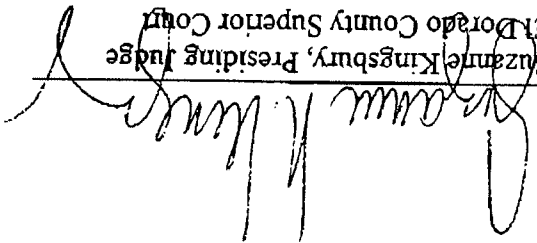
