Christmas Cheer, Inc. is a nonprofit organization committed to feeding and supporting vulnerable populations in El Dorado County. Among those we serve are veterans, many of whom face food insecurity and are often underserved by tradional systems. Currently we serve an estimated 40 to 80 veterans per month through our food pantry program, distributing food packages that include meat, bread, desserts, fresh produce, and non-perishable items. Additionally, we collaborate with the American Legion by delivering weekly suppliers of bread, pastries, and packages meals (typically sandwhiches). This effort ensures that veterans who gather at the legion have regular access to nourishing food and human connections.
