**FIFTH AMENDMENT TO AGREEMENT FOR SERVICES #316-S1611 / #598**

**THIS FIFTH AMENDMENT** to that Agreement for Services #316-S1611 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Mother Lode Van & Storage, Inc., a California corporation duly qualified to conduct business in the State of California, whose principal place of business is 11255 Pyrites Way, Suite 400, Rancho Cordova, California 95670 (hereinafter referred to as "Contractor");

**RECITALS**

**WHEREAS**, Contractor has been engaged by County to provide moving services and modular furniture disassembly, inventory, removal, and reinstallation services on an "as requested" basis for County facilities both on the East Slope and West Slope of El Dorado County, in accordance with Agreement for Services #316-S1611, dated January 26, 2016, Amendment I dated May 27, 2016, Amendment II dated June 6, 2017, Amendment III dated July 20, 2017, and Amendment IV dated January 22, 2019, all incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

**WHEREAS**, the parties hereto desire to amend the Agreement to increase the not-to-exceed compensation amount of the Agreement by \$100,000 amending **ARTICLE III, Compensation for Services**;

**WHEREAS**, the parties hereto desire to amend the Agreement to add a County notice recipient, amending **ARTICLE XXIV, Notice to Parties**;

**NOW, THEREFORE**, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Contractor mutually agree to amend the terms of the Agreement in this Fifth Amendment to Agreement on the following terms and conditions:

- I. **ARTICLE III, Compensation for Services**, fourth paragraph of the Agreement is amended in its entirety to read as follows:

The total amount of this Agreement, as amended, shall not exceed \$700,000, inclusive of all costs and expenses.

II. **ARTICLE XXIV, Notice to Parties**, is amended in its entirety to read as follows:

All notices to be given by the parties hereto shall be in writing and served by depositing same in the United States Post Office, postage prepaid and return receipt requested. Notices to County shall be addressed as follows:


