EXHIBIT 'A'

All that certain real property situate in Lot 5 of Section 19, Township 10 North, Range 11 East, Mount Diablo Meridian, County of El Dorado, State of California, being a portion of Parcel 3 as shown on that certain Parcel Map filed in Book 22, Page 28 of Parcel Maps in the Official Records of El Dorado County more particularly described as follows:


COMMENCING at the Southwest corner of said Parcel; thence along the westerly line of said Parcel North 7°01'41" West, 30.11 feet to the POINT OF BEGINNING; thence continuing along said westerly line North 7°01'41" West, 11.22 feet to the beginning of a non-tangent curve concave northerly, said curve has a radius of 270.00 feet; thence leaving said westerly line easterly along said curve through a central angle of 15°32'08" an arc distance of 73.21 feet, said curve being subtended by a chord which bears North 85°59'24" East, 72.99 feet; thence South 11°46'40" East, 1.20 feet to the northerly line of a right of way easement as described in Book 4946, Page 556 of the Official Records of said County; thence along said northerly line South 78°07'38" West, 73.25 feet to the POINT OF BEGINNING. Containing 332 square feet more or less.

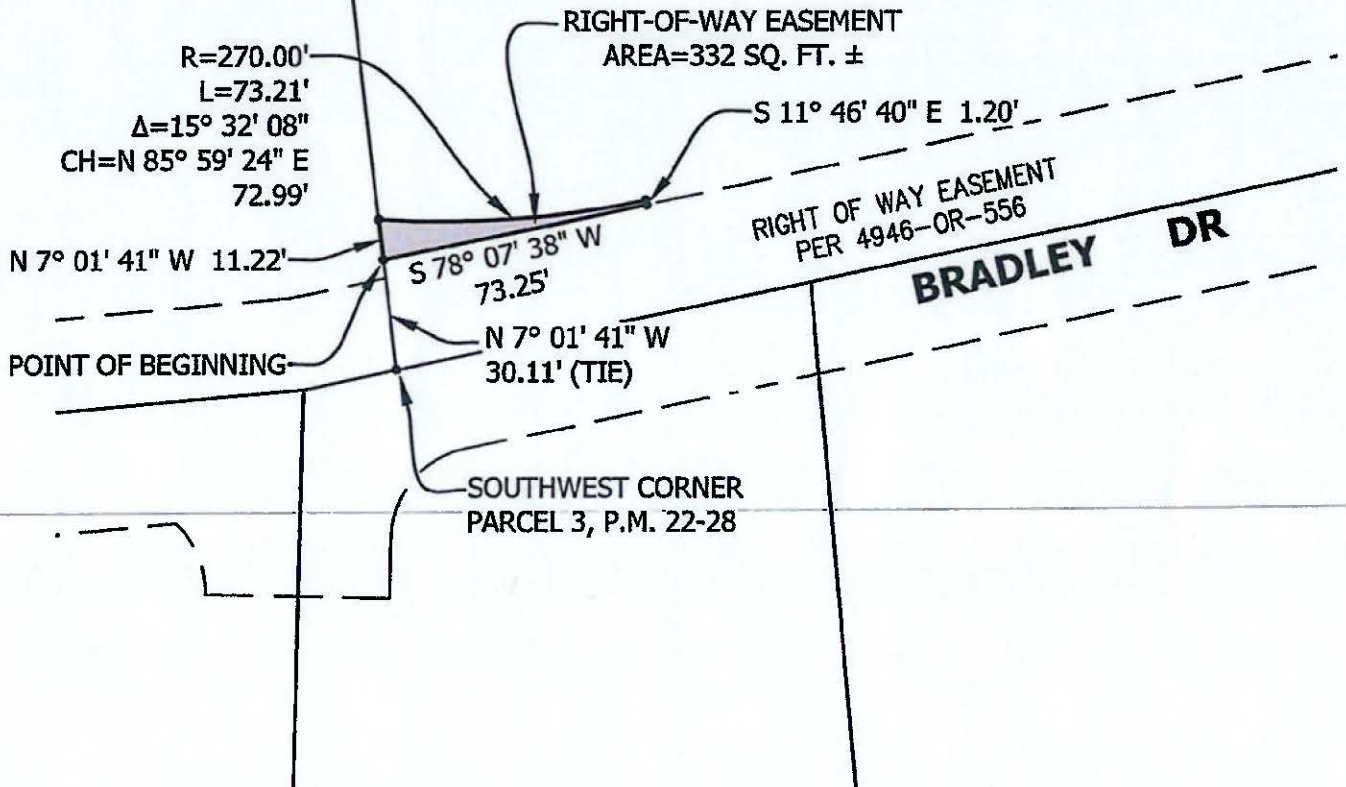
