Regarding tax revenues in the Missouri Flat area, in 2002, the Board of Supervisors pledged 85% of the "new" property tax and sales tax generated in the Missouri Flat area to fund the Missouri Flat Master Circulation Plan. A number of land use decisions and transportation planning decisions have been made based on these pledged revenues. Accordingly, the County does not have a great deal of incremental tax revenue to share with the City from the Missouri Flat area.
