Subject Bass Lake Road Detour Route

Dear Supervisor Baumann,

I am writing to you because our District 1 Supervisor, Rusty Dupray, has recused himself from the issue of where to place the detour while the southern part of Bass Lake Road is improved. As you are aware, that question is to come before the Board for a vote on this coming Tuesday

We would like you to be aware that Bass Lake Action Committee is in favor of the shorter and more convenient Silver Dove Way detour. We are opposed to the longer and less convenient detour that would use Country Club Drive, Tierra del Dios, Morrison Road and Hollow Oak Road route.

In addition, we believe that the Silver Dove route will better serve the needs of public safety, in that emergency vehicles will have less distance to traverse, and will have less congestion points that may slow their progress.

Therefore we urge you and the other voting supervisors to select the Silver Dove Way detour route when the question again comes before the Board of Supervisors on Tuesday.

The purpose of Bass Lake Action Committee is threefold: (1) to provide a voice for the community of Bass Lake in dealing with the County of El Dorado and other governmental and community agencies, (2) to ensure that the concerns of the community of Bass Lake regarding actions proposed by the County of El Dorado and other governmental and community agencies are addressed and that the proposed actions meet the community's needs, and (3) to keep the community of Bass Lake informed about community issues and related public meetings with respect to actions by the County of El Dorado and other governmental and community agencies.

Subject Preferred Bass Lake Road Detour Option

Dear Supervisor Baumann,

I am writing to you in regard to the detour route selection for the D.R. Horton improvements to the southern section of Bass Lake Road. When deciding on the proper alternative, please consider the convenience and safety of residents that currently use Bass Lake Road. I believe that Detour Option 1 (Silver Dove) would create fewer frustrations for local residents and would be the safest alternative.

Detour Option 4 (Morrison Road) utilizes a portion of Country Club Drive that has terrible traffic backlogs now, without the increased traffic that Detour Option 4 would add. If you wish to see first hand how bad the current situation is, drive down Country Club Drive from Cambridge Road to Bass Lake Road at 7:30 any weekday morning. Then imagine the situation after the additional traffic is re-routed down Country Club Drive with many of those traveling east on Country Club making a left hand turn, in front of traffic, onto Tierra De Dios Drive. I think that many drivers, after experiencing that mess, would decide that it would be better to travel Serrano Parkway to El Dorado Hills Blvd. and on to Highway 50 ramps there. The EDH Blvd./Highway 50 area has its own problems without the increased traffic.

Please choose Detour Option 1. D.R. Horton's preference for Detour Option 4 is based on their responsibility to their bottom line and their shareholders, as it should be. But our Board needs to look after us.
