Train Tracks - Resolution 10-0682

Supervisor Nutting:

I am writing to you today in regards to the train tracks running through our county. I have attended several meetings over the last 10 years where the right of way has been discussed, and I cannot believe we are still here today trying to figure out what to do. The right-of-way that El Dorado County purchased is an untapped resource for the county, and I urge you to move forward with the most cost-effective plan to extend the hiking, biking and horse trail as far as possible in the shortest amount of time.

In my opinion, Supervisor Sweeney has done a disservice to the county by continually pushing for an excursion train, when that is not in the best interest of El Dorado County. An excursion train has no chance of making any money, and to suggest that a multipurpose trail adjacent to the rail bed makes sense is absolutely ridiculous. The cost to rip up the tracks is minimal (or very possibly free) and could be completed in short time. A class 1 multipurpose trail on the rail bed would cost about \$400k per mile after that, with many opportunities for grants to help make that number even lower.

On the other hand, if the county was to decide on a class 1 trail adjacent to the rail bed, the cost skyrockets to anywhere between \$1 million to \$3 million per mile. This is clearly cost prohibitive and further stalls the implementation of any trail. Right now the many parts of the track are not conducive bikes and horses so it is not used frequently. With the lack of use, the trail has become ripe for illegal use of motorcycles. This is a problem that law enforcement cannot do much of anything about. But once the tracks are ripped out, the trail will attract more users and make illegal use much more difficult.

Now Mr. Sweeney is trying to extend the Demonstration Train out of El Dorado beyond what has been recommended and it makes no sense. The 3/4 mile proposal is a great idea because the tracks in that area are laid in a wide, flat area where a multipurpose trail can be added next to the track without a huge cost. But what has been proposed in Resolution 10-0682 does not make sense. The terrain in this 3 mile area would make it extremely expensive to add a trail next to the track.

I strongly urge you to push for a multipurpose trail from Folsom to Placerville (on the rail bed with the tracks removed) because it would create a trail of national significance to El Dorado County at the lowest cost to the county. This sort of trail would attract people from all over to our county solely because of the opportunity to ride from downtown Sacramento to Placerville, Camino and hopefully some day Lake Tahoe.

Any train agreement on the right-of-way beyond the 3/4 mile demonstration train in El Dorado is not in the best interest of the people in El Dorado County.



El Dorado County Board of Supervisors -

We were quite astonished and dismayed to learn just this weekend that Supervisor Sweeney has put a resolution on next Tuesday's Board of Supervisor's agenda that favors the excursion train proponents. We are told that the purpose of Agenda Item #57 is to authorize to "operate a historical railroad operation" on the tracks from Mother Lode Drive to Missouri Flat Road.

We know that all of you received letters from many County residents about two weeks ago, indicating that we do not want to see the for-profit train being allowed to monopolize the course. It had seemed to us that you were listening. But, unless this is a Jack-Sweeney-Only thing, you clearly are not. Was the form reply that came to us from Supervisor Sweeney's office that stated, "there is not a vote [regarding trains] before the JPA Board or the EDC Board that is happening anytime soon, "simply a put-off and a lie???

We can't help but believe that the fact that Agenda Item #57 was slipped in so quickly, was under-handed and an attempt to circumvent an open process. Or did some unusual/unknown thing happen to make this suddenly so urgent? Regardless, by putting trains on the rails now, you are ignoring the many emails that have opposed an excursion train, especially if it means not having a multi-purpose trail. The emails you have received represent just a small portion of the support in this county for a trail --- as you would know if you were to venture to the newest section. On a weekend, the parking lot is always packed, and the trail is filled with enthusiasts! What more do you need to know what the people in this county want – or do you care?

To be clear, we do not flatly oppose the concept of a train museum and the ¾ mile of demonstration rail, and <u>open</u> discussion of all options is a righteous thing to do. At the same

time, there is no urgency to run a train for a museum that hasn't even been funded or built yet, so it seems rather underhanded that this agenda item is being slipped in now. There are many negotiations and compromises to be made along the 28 miles of track from Placerville to Latrobe. We urge you to follow a FAIR and transparent process, allow all the arguments to be made and an ethical process to take place. From our perspective, it is a matter of honesty and integrity.

Our hope is that you are not all of the same mind as Mr.. Sweeney. We are asking you to vote NO this next Tuesday, June 29, to the resolution of the train folks to "operate a historical railroad operation" on the tracks from Mother Lode Drive to Missouri Flat Road.

There is a currently a proposed Historical Train Park and a Demonstration Train in the town of El Dorado. This project has been planned and reviewed by all stakeholders and is a perfect spot to preserve history. The Demonstration Train will run from El Dorado to Blanchard Road, about .75 mile distance.
