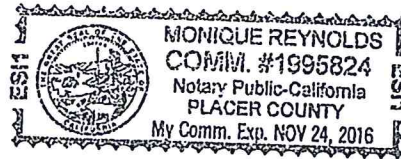

Storm Drain Easement


