Ms. Stout,

The El Dorado County Board of Supervisors approved the use of Development Impact Mitigation Fees (DIF) to fund approximately 50% of the purchase of our new Ladder Truck, with additional approval to fund the necessary equipment for the new piece of equipment.

The Fire District has received the ladder truck and equipment to placed the unit in service at Station 28 in Shingle Springs. During the process of placing the unit inservice, we discovered a compatibility issue with our newly purchased Self-Contained Breathing Apparatus (SCBA) and our Rapid Intervention Team packs and our Rescue Airbags. To have those items functional with our new SCBA's, the following items are requested for Truck 28, purchasing with our DIF's:

- SCOTT Tool Adapter for Cylinders, 2 @ \$594.80 per unit
  - Total cost with tax: \$1,275.85
- SCOTT RIT III packs, 2 @ \$3,577.34 per unit
- SCOTT Carbon Cylinder for RIT III, 2 @ \$1,566.27
  - Total cost for 2 RIT III packs with cylinders and tax: \$11,033.05

Our request for the additional equipment for Truck 28 totals: \$12,308.90.

I am attaching the quotes we received from AllStar Fire Equipment for both the adapters and the RIT III packs.
