### THIRD AMENDMENT TO AGREEMENT FOR SERVICES #4832

THIS THIRD AMENDMENT to that Agreement for Services #4832 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Pro-Line Cleaning Services, Inc., a corporation duly qualified to conduct business in the State of California, whose principal place of business is 6100 Enterprise Drive, Suite G, Diamond Springs, California 95617 and whose mailing address is Post Office Box 850 Diamond Springs, California 95617 (hereinafter referred to as "Contractor");

### RECITALS

WHEREAS, Contractor has been engaged by County to provide routine janitorial services for its Public Safety Facility located at 200, 220, and 240 Industrial Drive, Placerville, California 95667, in accordance with Agreement for Services #4832 dated May 11, 2020, First Amendment to Agreement for Services #4832 dated September 1, 2020, and Second Amendment to Agreement for Services #4832 dated December 16, 2020, incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

**WHEREAS**, the parties hereto desire to amend the Agreement to extend the expiration date to December 31, 2021, amending **ARTICLE II, Term**;

WHEREAS, the parties hereto desire to amend the Agreement to increase the not-to-exceed compensation amount of the Agreement by \$46,860 for a new not-to-exceed amount of \$167,915, hereby amending ARTICLE III, Compensation for Services;

**NOW, THEREFORE**, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Contractor mutually agree to amend the terms of the Agreement in this Third Amendment to Agreement for Service #4832 on the following terms and conditions:

I. ARTICLE II, Term, of the Agreement is amended in its entirety to read as follows:

#### ARTICLE II

**Term:** This Agreement shall become effective upon final execution by both parties hereto, as amended, and shall cover the period of March 17, 2020 through December 31, 2021.

**II. ARTICLE III, Compensation for Services,** of the Agreement, third paragraph is amended to read as follows:

The total amount of this Agreement, as amended, shall not exceed \$167,915, inclusive of all costs, taxes, and expenses.

Except as herein amended, all other parts and sections of Agreement for Services #4832, as amended, shall remain unchanged and in full force and effect.
