DESCRIPTION OF THE PROJECT The work done is described in the Special Provisions and shown on the Plans, and generally consisted of, but was not limited to: drainage, roadway and retaining wall improvements to repair a failed culvert and section of the roadway that includes: removal of an existing 36" CMP culvert and replacement with a 60" plastic pipe culvert with an 84" storm drain manhole; installation of 12" CMP culvert and overside drain; construction of a reinforced concrete headwall; enhancements to the existing retaining wall footing, roadway excavation, structure backfill with slurry cement, Class 2 AB and HMA (Type A) to reconstruct the roadway section and shoulder backing.


