

My purpose this morning is to address the BOS regarding their DUTY to respond in a timely manner to constituent concerns about non-compliance with Public Record Act requests.

On February 25th I submitted a CPRA requesting information concerning the name, address and policy number of the Indemnity & Liability bonding agency for the legislative statutes for the County of El Dorado. The information I was seeking was not provided so on March 11th I re-submitted another CPRA requesting a CURRENT copy of the CSAC Excess Insurance Authority covering the LEGISLATIVE STATUTES for the county of EDC.

The reply received from Risk Management on March 31st contained an undated and unsigned endorsement #76 from page 414 of the 418 page policy. It DID NOT provide any information whatsoever regarding the legislative statutes required by law. Therefore I am resubmitting yet another CPRA requesting the following information:

- A **copy** of Resolution 302-99.
- An **explanation** why Resolution 302-99 no longer exists on the EDC Government website as indicated by Risk Management.
- A **copy of any/all other primary bonding insurer that covers all legislative statutes required by law** for the County of El Dorado.

You've heard it said before, ***"In politics nothing is accidental. If something happens, be assured it was planned this way..."***

As you are aware, the Mt. Murphy Road Bridge Stakeholder Advisory Meeting is being held THIS EVENING at 5:30 PM at the Coloma Grange Hall. I'd like to read the definition of a stakeholder as it applies to Sustainable Development, also known as United Nations Agenda 21.

Stakeholder Forum is an INTERNATIONAL organization working to advance SUSTAINABLE DEVELOPMENT and promote democracy at a global level. Our work aims to enhance open, accountable and participatory international decision-making on sustainable development through enhancing the involvement of stakeholders in intergovernmental processes.

The organization seeks to provide a BRIDGE between those who have a stake in SUSTAINABLE DEVELOPMENT, and the international forums where decisions are made IN THEIR NAME. To this end, we work with a diversity of stakeholders globally on international policy development and advocacy; stakeholder engagement and consultation; media and communications and capacity building—all with the ultimate objective of promoting PROGRESSIVE outcomes on SUSTAINABLE DEVELOPMENT through an open and participatory approach.

Before I proceed, I wish to make an important distinction about the Agenda 21 Resolution that was tabled indefinitely after the 5/15/12 BOS meeting. I am NOT a STAKEHOLDER. I am a PROPERTY OWNER on Mt. Murphy representing resident PROPERTY RIGHTS threatened by the reality of Agenda 21 being implemented by 'stakeholders' throughout the American River corridor, El Dorado County and the state. Agenda 21 jeopardizes individual liberties, property rights, and precious freedom for the "greater good of the community" via these types of forums. There's nothing 'good' about it.

Returning to my topic, a Public Records Act request relevant to the Coloma Resort and the Mt. Murphy Road Bridge CIP was submitted on February 25th. A comprehensive response was due March 11th. It appeared there was some confusion about the information being requested yet Kim Kerr neglected to indicate a DATE when I could expect to receive her written response as required by Government Code Section 6253(c). I received her overdue response on April 4th.

Then the Board received two more CPRAs via email on March 31st and April 2nd relevant to the Coloma Resort on Mt. Murphy Road which I am submitting for the public record.

Additionally I'm submitting for the record another two CPRAs that were emailed to the Board yesterday regarding a very disturbing incident on Friday, April 4th involving EDSO deputy Cessna, the Coloma Resort and historic Mt. Murphy Road.

What transpired when two deputies arrived at my home AT MY REQUEST only confirmed why citizens have lost confidence in the ability of law enforcement to do what the public expects of civil servants. It soon became apparent the situation was deliberately provoked by representatives of the Coloma Resort and was retaliatory in nature, very likely due to the number of CPRAs submitted to the County and State Parks. The responding deputy's actions were inappropriate and unjustified so it was necessary to adamantly order them OFF MY PROPERTY. You'll be hearing more about this later, and so will the Sheriff.

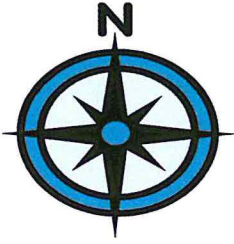



I have a proposal for the Board to consider that would address several of the fire safety issues that concern us, residents of the various neighborhoods of Pollock Pines. These include the need for more clearly identified County responsibilities. It would involve the County making a request for some of the California fire prevention fee funds to be applied to county supported programs*. These programs would include funds covering production and distribution costs for specific fire safety information to be distributed to county residents and visitors similar to the pamphlet that Heather Campbell has prepared. The funds could also be used by the county agencies for programs to implement action to establish defensive space as needed for Seniors, the disabled and other categories of residents that could use assistance. The county could also establish its own wildfire fighter teams that would supplement and work with (and be trained by) the CalFire program. These teams would provide needed employment opportunities for residents (including teenagers during the Summer?) who are out of work as well as contract opportunities for local companies that have the necessary hardware and machinery. These teams could be specific to the brush clearance work needed to establish the defensive space mentioned above.

Another problem that could be addressed would be the unoccupied and undeveloped lots located in our communities that are extreme wildfire hazards. The county could consider developing and passing legislation that would require absentee owners to effectively clean their property to defensive space standards...and if they choose not to do it, have the county teams do the clearance and attach the costs as a lien on, or a tax charged to their property.

The requested State funds could also be used to develop, practice and implement public safety activities involving community wild fire evacuation plans.

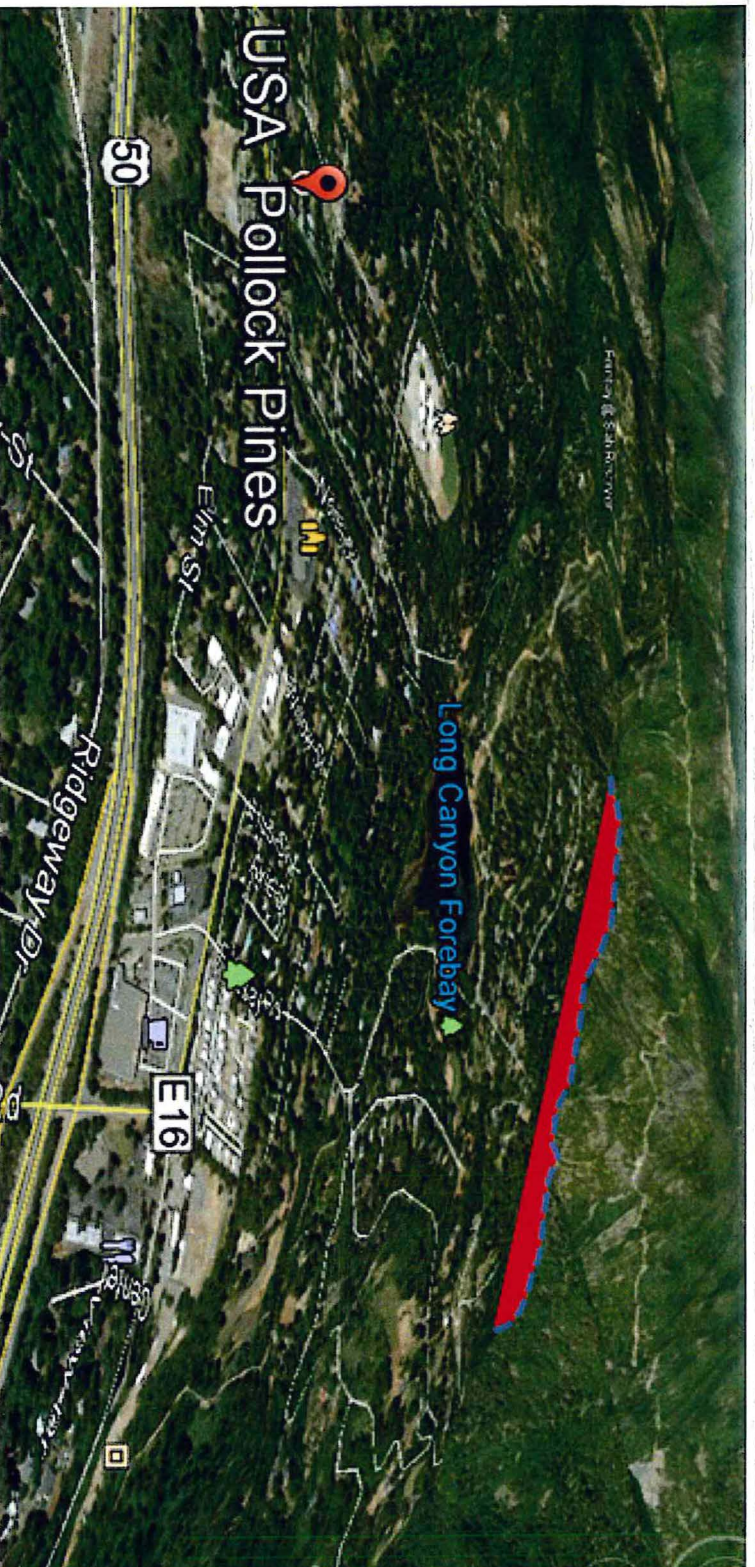
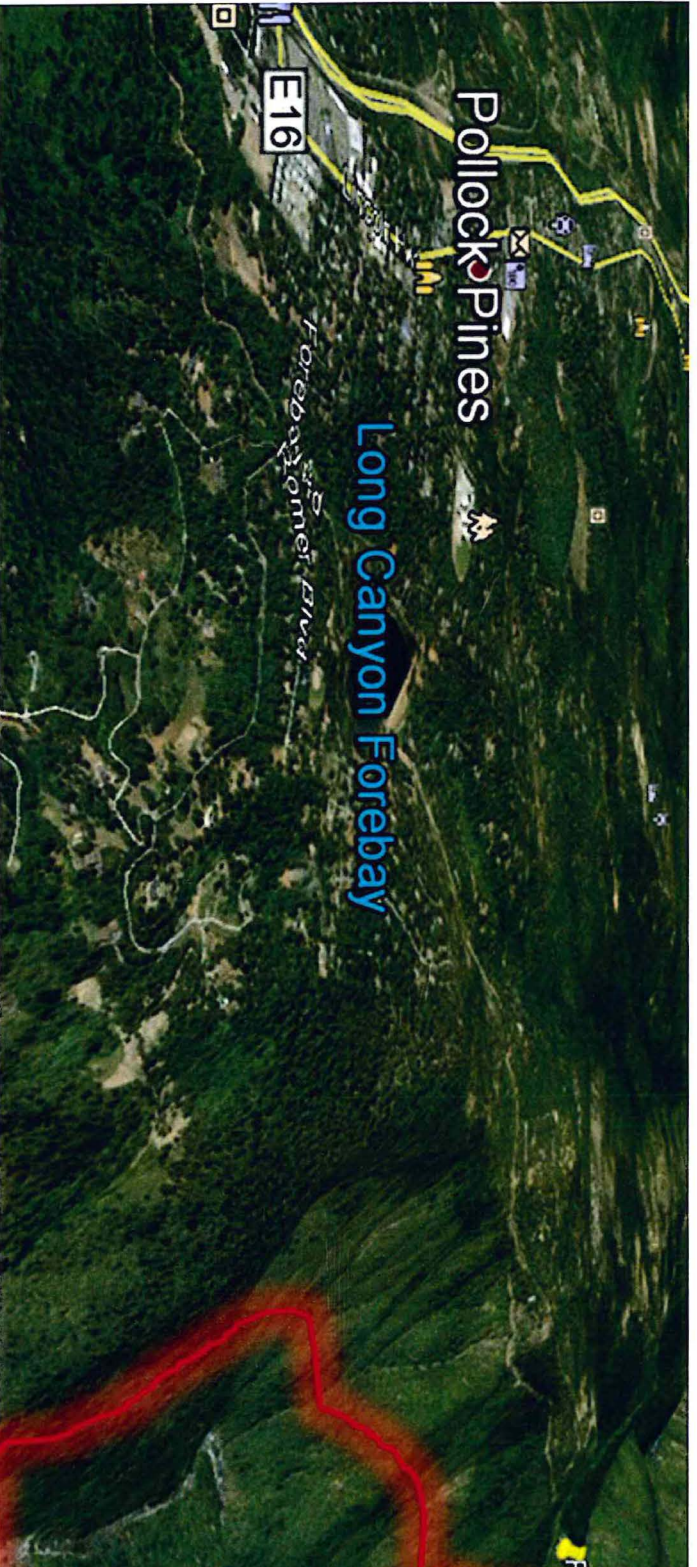
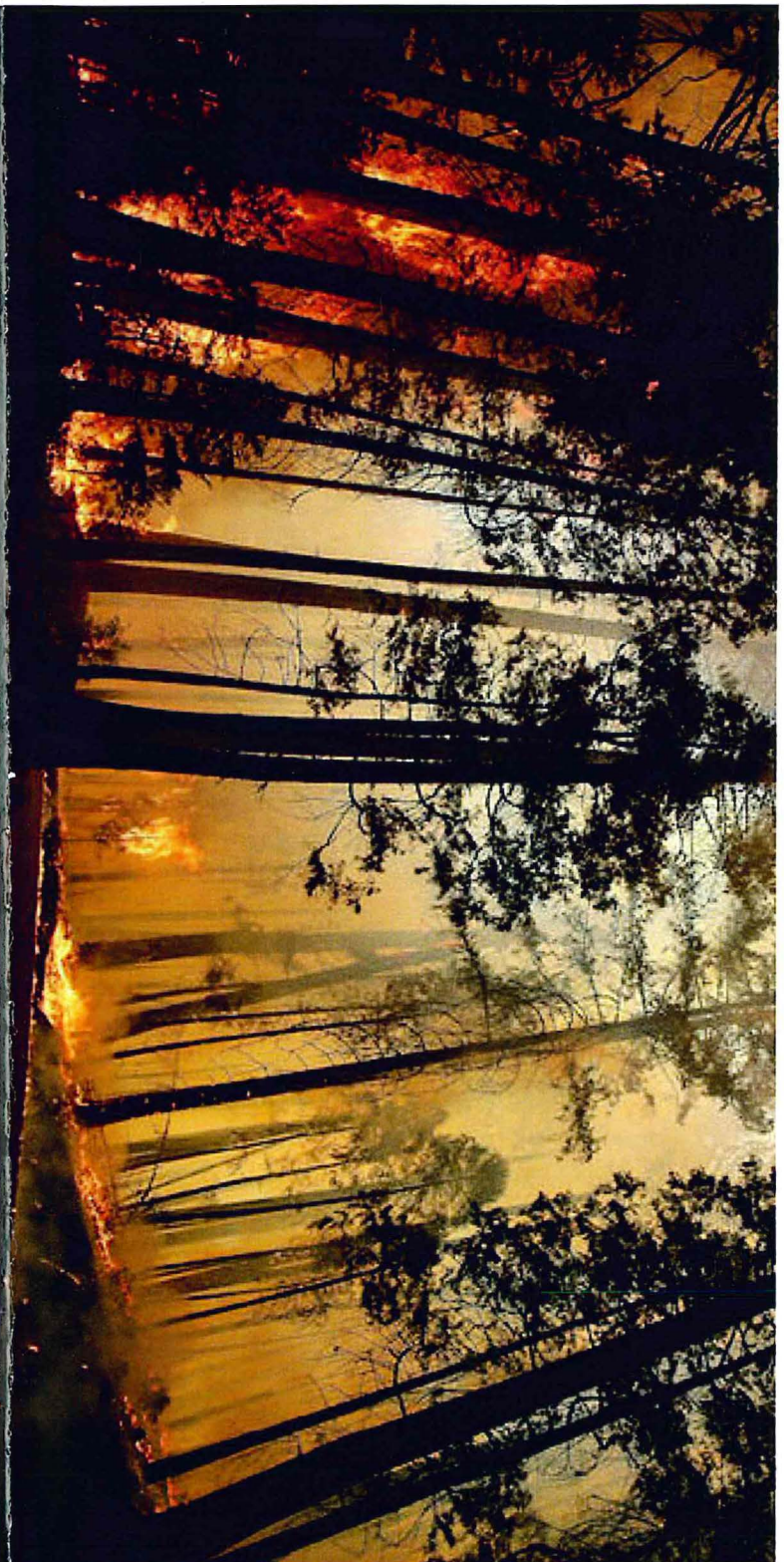
BOS TALKING POINTS

H. Campbell 4-8-14 Open Forum

Heather Campbell 4/8/2014

- Within This County, the Community of POLLOCK PINES is Uniquely Located, Where an Incident Type WILDLAND FIRE coming out of the AMERICAN RIVER CANYON ... Will OVERWHELM the COMMUNITY
 - Know-one can predict the year or day – but it will happen someday, as fire has always been a part of our ecosystem
 - This community - but more to the point – its elderly and disabled, needs to understand the potential fire danger we live with and plan ahead for it
 - In the last ten years, wildland *fires have grown in size, duration and activity level.*
 - As the fuel moistures have been decreasing each year, the ignition components required to ignite these fires are much more prevalent.
- For this reason, I DEVELOPED an EVACUATION ACTION PLAN to help Inform the Public of both the WILDLAND FIRE DANGER and to PREPARE For The WORST
 - A community unprepared for an Incident Wildland Fire is at grave risk – from its resident being trapped by fire and dying. This initial push, is squarely directed towards saving lives.
 - CEDAPP funded the first batch of Wildland Fire Preparation fliers I put together. These are being hand distributed to the residents most at risk; primarily along the Forebay and Blair road systems.
 - The Fire Safety Council funded the second batch, in brochure quality, to distribute to the area businesses around Pollock Pines and for the two Community Meetings scheduled in April and May
 - And Jeanne Harper of CEDAPP, has organized the panel that will respond to public questions, after the evacuation presentation.
 - I'm deeply disappointed that my District 5 Representative, Norma, has not acknowledged any of my e-mails or voice message.
- There are PUBLIC SAFETY avenues the County can support
 - In order to SAFELY EVACUTE during a Wildland FIRE EMERGENCY, the ROADS have to be drivable or the public will stop and block the roads
 - Currently the accesses onto HWY 50, and portions of HWY 50, are over grown with concentrations of small trees. These areas need to be thinned out for Public Safety
 - If a fire does come out of the American River Canyon, the *biggest ignition threat* is at the Dispersed Recreation site, located at the *bottom of Forebay Rd at Slab Reservoir.*
 - During the summer, parties do occur there during Fire Restrictions, the Sheriff's Office can help assist in two ways
 - The Deputies currently do not normally patrol there - as it outside of their expected response zones. Make it a priority to patrol for illegal fires during expected high use periods
 - The Office can also monitor social networking to alert ECC of potential threats
 - The County needs an *Ordinance, which compels absentee landowners to clear their properties of latter fuels, or the county will do it for them and hand them a bill.*
 - And, If an Ordinance has been done before, you're not having to reinvent this wheel
 - Currently there is no suppression plan in place to protect the community of Pollock Pines from a known wildland fire danger.
 - Please work with the Forest Service and State Officials to put an action plan in place.
 - Such as; Building a fuel break along the American River Canyon ridgeline before a fire starts
 - Work with the Mobile Home parks to insure their evacuation plans are in order

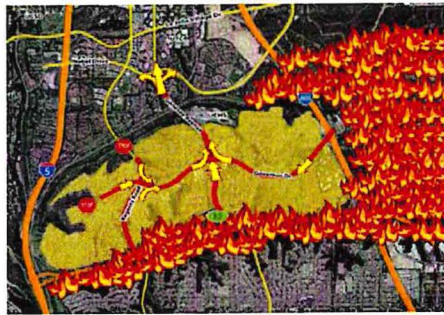
How the Public Perceives & Responds to Fire Activity Has To Change.

Fire Weather Has Been Increasing.

- Long before Global Warming became a household term:
 - In the 80's – Fire restrictions were rare / now it is the norm.
 - In the 90's – When wildland fires ignited, a low humidity level was 20% / now it's in the single digits.
 - Since 2000, wildland fires have grown in size, duration and activity level.

Know Your Escape Routes



When it is time to GET OUT
Avoid Congested Roads, Get Out Early

When Is It Time To Leave?

- Is it when the authorities advise to evacuate?
- Will you recognize the dangers to have enough time to get out?
- Do I take the time to load up my belongings?
- What if a fire comes in the middle of the night?
- Will the roads be passable or congested?
- Remember responding fire crews use the same roads and others will be evacuating.

Many of these answers depend on your homes location and its risks factors.

As time permits, unprepared evacuees often make their decisions on what to take with them as they are fleeing.

- Sentimental property is not worth dying for: albums, jewelry, family heirlooms and paintings. Prepare ahead if you want to have a chance at saving your important items.

TIPS

- Prepare ahead for an extended fire closure.
- During a closure, you need to validate your home address to reenter. Bring documentation of your address.
- Make evacuation preparations for friends and relatives with special needs.
- Review and update your home insurance policy.
- Turn on an exterior light, so firefighters can see your house in the dark and smoke.

Prepare a GO BAG

- ✓ It should be a size easy to handle and store
- ✓ Go Bags are intended for when there is no time
- ✓ Clothing for one week, w/ sleepwear
- ✓ Medications
- ✓ Toiletries, shampoo, soap, toothbrush
- ✓ Flashlight, travel clock, Reading material
- ✓ Towel

Hotels can be over whelmed with fire personnel and evacuees; you may be staying at a shelter.

Prepare for Pet Care

- ✓ Store your pet supplies in one location, for a quick grab.
- ✓ Fill your pet kennel with:
 - Pet food - one week supply
 - Leashes, medication, water bowl
- ✓ Make arrangement with a neighbor to remove animals if you're not home during a wildland fire event.

Consider What Documents to Protect

- ✓ Driver's License, Health Insurance Card, House Deed, Insurance Papers, Legal Documents, Marriage License, etc.
- ✓ Photograph the contents of your home (including closets)
- ✓ Have vital documents stored in a locking fire box to take with you, or keep copies at another safe location.
