



**RESOLUTION NO. 038-2022**

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

**Resolution Adopting Turn Restrictions from North Upper Truckee Road to Westbound U.S. Highway 50  
and from Sawmill Road to Westbound U.S. Highway 50**

**WHEREAS**, the County of El Dorado Ordinance Code Section 10.04.030 authorizes the Board of Supervisors to establish turn restrictions; and

**WHEREAS**, California Vehicle Code Section 22101 authorizes local authorities to place or erect official traffic control devices within or adjacent to intersections to regulate or prohibit turning movements at such intersections; and

**WHEREAS**, on August 5<sup>th</sup>, 2020 the Lake Tahoe Traffic Advisory Committee recommended the addition of turn restrictions from North Upper Truckee Road to Westbound U.S. Highway 50 and from Sawmill Road to Westbound U.S. Highway 50; and

**WHEREAS**, these turn restrictions began between May 1<sup>st</sup>, 2021 and May 22<sup>nd</sup>, 2021 and were to be terminated on Sunday, October 31<sup>st</sup>, 2021, and all turn restriction related traffic control regulatory and advisory signs on Lake Tahoe Boulevard, Sawmill Road and North Upper Truckee Road were to be removed before Sunday, November 7<sup>th</sup>, 2021; and

**WHEREAS**, the Caldor Fire began on August 14<sup>th</sup>, 2021 and U.S. Highway 50 was closed from August 20<sup>th</sup>, 2021 to September 21<sup>st</sup>, 2021, and thus the Turn Restriction Pilot Program was interrupted, and the data gathered was incomplete; and

**WHEREAS**, new turn restrictions will begin between May 1<sup>st</sup>, 2022 and May 21<sup>st</sup>, 2022 and terminate on Sunday, October 30<sup>th</sup>, 2022, and all turn restriction related traffic control regulatory and advisory signs on Lake Tahoe Boulevard, Sawmill Road and North Upper Truckee Road will be removed before Sunday, November 6<sup>th</sup>, 2022; and

**WHEREAS**, these turn restrictions can be rescinded at any time by the El Dorado County Director of Transportation.

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Supervisors of the County of El Dorado hereby adopts a Resolution that establishes turn restrictions as follows:

“(a) On Sawmill Road (No. 2202) right turns to U.S. Highway 50 be prohibited on Sundays and Holidays between the hours of 10:00 am and 4:00 pm”

“(b) On North Upper Truckee Road (No. 159) right turns to U.S. Highway 50 be prohibited on Sundays and Holidays between the hours of 10:00 am and 4:00 pm”
