



## RESOLUTION NO. 122-2013

### OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

**WHEREAS**, County Ordinance Code section 5.04.050 defines "carnival" as including the operation of any two or more of the following devices within five hundred feet (500') of each other: merry-go-round, ferris wheel, and carnival-type ride, shooting gallery or pony ride; and,

**WHEREAS**, the operation of a carnival in the County requires that the operator obtain a County business license pursuant to County Ordinance Code section 5.12.050; and,

**WHEREAS**, in order to obtain the business license, County Ordinance Code section 5.12.050 requires the applicant to obtain a resolution of the Board of Supervisors declaring that the public health, safety and welfare will not be endangered by the business at the location specified in the business license application, and, will not violate any zoning or health laws or regulations and to present a certified copy of the Board of Supervisors' resolution with the business license application; and,

**WHEREAS**, prior to the adoption of any such resolution, the Board of Supervisors shall hold a public hearing on the matter and publish public notice of the time, place and purpose of which has been published in a newspaper of general circulation in the County at least ten (10) days before the hearing as required by County Ordinance Code section 5.12.050; and,

**WHEREAS**, on July 23, 2013, Wold Amusements filed a business license application, received an approved, conditional Temporary Use Permit, and has supplied all that is required for the operation of a carnival in the unincorporated area of El Dorado County for August 30, 2013, through September 1, 2013, and that public notice was given on this hearing in accordance with County Ordinance Code 5.12.050.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Supervisors, that sufficient evidence has been presented of compliance with the requirements for the issuance of a business license for the operation of the Wold Amusements carnival and that the operation of the business does not endanger the public health, safety and welfare and does not violate any zoning or health laws or regulations.

**BE IT FURTHER RESOLVED** that the Board of Supervisors hereby adopts this resolution for the approval of the business license submitted by Wold Amusements for the operation of a carnival at the Heavenly parking lot for the first Annual Kiwanis Community Fair held August 30, 2013, through September 1, 2013.
