



## RESOLUTION NO. 092-2025

### OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

#### REPLACING RESOLUTION NO. 045-2025 DESIGNATING PARKING RESTRICTIONS FOR COUNTY-OWNED OR OPERATED PARKING LOTS

**WHEREAS**, on April 22, 2025 the Board of Supervisors adopted Resolution No. 045-2025 designating parking restrictions for County- owned or operated parking lots per the County of El Dorado Ordinance Code Section 10.12.145; and

**WHEREAS**, the Board of Supervisors desires to clarify the parking exception at 360 Fair Lane; and

**WHEREAS**, Resolution No. 045-2025 will be replaced in its entirety by this Resolution;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Supervisors of the County of El Dorado that Resolution No. 045-2025 is hereby repealed and replaced with this Resolution to designate as restricted parking lots, subject to the exceptions set forth in El Dorado County Ordinance Code Section 10.12.145, the following County-owned or operated parking lot locations pursuant to El Dorado County Ordinance Code Section 10.12.145 as follows:

(1) A person shall not park or leave standing any vehicle between the hours of 9:00 p.m. and 6:00 a.m. Monday through Friday and at any time on Saturday and Sunday at the following locations designated in Table 1:

Table 1 – Prohibited parking Monday through Friday between 9:00 p.m. and 6:00 a.m. and any time Saturday and Sunday

(2) A person shall not park or leave standing any vehicle between the hours of 9:00 p.m. and 6:00 a.m. of any day, and shall not park or leave standing any vehicle in excess of two (2) hours between the hours of 6:00



a.m. and 9:00 p.m. on Saturday and Sunday, at the following locations designated in Table 2. A vehicle will be deemed to have been parked or left standing in excess of two (2) hours if it has not been moved out of the parking lot following the expiration of the two (2) hour time limit on a Saturday or Sunday and a vehicle may not re-park in the same parking lot with time restricted parking for the remainder of the day.

Table 2 – Prohibited parking between 9:00 p.m. and 6:00 a.m. on any day, and time-restricted 2-hour parking between 6:00 a.m. and 9:00 p.m. on Saturday and Sunday.

360 Fair Lane - Veteran Memorial parking spaces designated as posted by signs giving notice thereof, up to five (5) spaces	Veteran Memorial at Government Center

(3) A person shall not park or leave standing any vehicle between the hours of 9:00 p.m. and 6:00 a.m. Monday through Saturday and at any time on Sunday, at the following locations as designated in Table 3:

Table 3 – Prohibited parking Monday through Saturday between 9:00 p.m. and 6:00 a.m. and any time Sunday.
