

Dear Supervisor Turnboo:

I am one of your constituents in District 2. Please accept this comment on the proposed Resolution opposing Proposition 50. I urge the Board to not take a position and *let the voters decide* for the reasons I explain below.

By way of introduction, I am an experienced election law attorney. I formerly served in County Counsel offices in Humboldt and San Benito Counties representing the elections departments, including litigation in state and federal courts. I advised the Board of Supervisors in San Benito County in redistricting supervisor district boundaries after the 2020 census. For two years prior to July of this year I was employed by the County Counsels' Association of California that provides support for all 58 County Counsel offices in California.

El Dorado County is well represented by highly capable attorneys in its County Counsel office. I do not purport to supplant legal advice given to the Board by them. In my experience, County Counsels provide advice on the law and procedures, but leave the policy decisions up to the Board. In this letter my intent is not to address the law, but to discuss the wisdom and policy of the Board in considering the proposed Resolution.

Article II, Section 6 of the California Constitution provides that all county offices shall be nonpartisan. As your County Counsel would no doubt advise you, legally that does not prevent the Board or its individual members from taking a position supporting or opposing any state or local ballot measure. However, I respectfully suggest that it is not wise for the Board to do so.

It is my understanding that this agenda item was prepared in response to a request from an organization strongly advocating against Prop 50. It would be wise for the Board to thoroughly consider the matter before making a decision on whether or not to take the proposed action.

Proposition 50, entitled the Election Rigging Response Act, is highly partisan. Passions are high on both sides. Prop 50 is focused on a mid-decade battle between states of Texas and California to redistrict Congressional districts for the House of Representatives. Control of the legislative branch of the federal government after the 2026 midterm elections in either Republican or Democrat hands is the central issue at stake. The outcome of that election will determine whether

or not Congress will again assert its Constitutional role to provide checks and balances to alleged excesses of and overreach by the Executive branch. What does that mean for El Dorado County government? Opinions may differ widely.

We can all be proud that El Dorado County voters are highly engaged. It is among the top three counties in the state for registration of eligible voters with about 95% of those eligible registered, behind only Placer and tied with Nevada County. In El Dorado County no political party is in the majority. According to the most recent report issued by the California Secretary of State, 29.63% of El Dorado County voters are registered Democrats, 42.17% are Republicans, and 18.54% are registered as No Party Preference, with the balance of less than 10% divided between other parties including American Independent, Green, and Peace & Freedom parties.

Voters in El Dorado County don't need or want the Board of Supervisors or anyone else telling them how they should vote. They can and will make up their own minds. Taking a stand on such a highly partisan issue favoring one party over another disrespects and does a disservice to a majority of El Dorado County voters who are aligned with another party or who have no party preference. This is especially true when no strong interests of County government is at stake.

The reasons stated in the draft resolution currently before the Board simply have no relevance to El Dorado County. Prop 50, should it pass, does not divide any community in this county. Instead of two representatives in Congress, El Dorado County would be represented by three Congress persons. On its face this would seem to give the County *more* clout in Congress, not less. (See AB 604, and attached current and proposed maps).

Current Congressional district maps place the eastern portion of El Dorado County in the 3rd District, which now includes all or portions of nine other counties, from Plumas to Death Valley. The maps proposed by Prop 50 reduce the number of counties in the 3rd District to four instead of ten (Nevada, Placer, El Dorado and Sacramento), mostly those in the Sacramento metropolitan area or that are closely related to Lake Tahoe— a much more cohesive community of interest.

The 5th District, encompassing the western portion of our county, currently includes all or portions of seven other counties. Under Prop 50 most of El Dorado County that is currently in the 5th District will move into the 7th District with portions of just three counties instead of eight (El Dorado, Sacramento, and San Joaquin) with both rural and urbanized areas in each — again, a much more cohesive community of interest.

Only a small portion El Dorado County would remain in the 5th District, which would then be comprised of all or portions of twelve counties, including both eastern and western slopes of the Sierra south of Lake Tahoe with desert and urbanized central valley areas.

The El Dorado County Supervisor District Map adopted by the Board in 2021 divides the community of Cameron Park between Districts 1, 2 and 4. Division of communities would not therefore seem to be a reason to oppose Prop 50 that would be consistent with past County Board decisions.

Prop 50 does indeed divide some cities or communities elsewhere in the state. However an objective analysis found not much difference from the number of community divisions in current maps adopted by the Citizen Redistricting Commission in 2021 (See, *CalMatters*, Jeanne Kuang, October 10, 2025, https://calmatters.org/politics/2025/10/proposition-50-communities-split/). In creating districts with equal population as required by the 14th Amendment of the United States Constitution as it has long been interpreted by the one-person-one vote rulings of the U.S. Supreme Court, and California law, it is sometimes necessary to divide local communities.

In sum, Proposition 50 does not adversely impact the interests of El Dorado County as a local government. It is a highly partisan issue of national politics with strong feelings on both sides. Regardless of whether the Board of Supervisors supports or opposes Proposition 50, most likely more than half of the voters in the County will be alienated and angry. There is no reason for the non-partisan elected members of the Board of Supervisors to take a stand on Prop 50. **Just Let the voters decide**.

I therefore respectfully suggest that the members of the Board of Supervisors of the County of El Dorado neither move nor second a motion for the adoption of the proposed Resolution in Item 41 of the agenda, File # 25-1727. If advanced to a vote, I suggest that a majority of the Board vote against passage of the Resolution in the best interest of community and respect for El Dorado County's well-informed voters of all persuasions.


Let the voters decide! This is supposed to be a democracy and paid public servants should not propose resolutions at a board meeting when they are on the board!

I am writing as a resident of El Dorado County to strongly request that the El Dorado County Board of Supervisors NOT adopt a position of opposition to Proposition 50 on the November 2025 ballot.

Agenda Item 41 for the October 21st Board of Supervisors meeting is shown in File # 25-1727 under the title: Supervisor Turnboo recommending the Board adopt and authorize the Chair to sign Resolution 136-2025 opposing Proposition 50.

A reading of the Resolution proves it to be misleading to voters of El Dorado County, with incorrect and incomplete information. That is out of step with the EDC Board of Supervisors stated mission on your government website, https://www.eldoradocounty.ca.gov/County-Government/Board-of-Supervisors: Together, we enhance the well-being of all residents, businesses, and visitors by delivering effective public service.

Effective public service requires telling the public the truth with accuracy and appropriate context. However, Resolution 136-2025 fails to do that. The most essential information is omitted, which is why Proposition 50, the Election Rigging Response Act, is being offered as a constitutional choice to Californians. It is in response to partisan mid-cycle redistricting in Texas that was projected to yield a five-seat Republican gain, upon President Trump stating Republicans were "entitled to 5 more seats", and without Texans' approval. The purpose of Prop 50 is to defend free and fair elections by countering the partisan advantage created by Texas, and to protect California's representation in the U.S. House in the 2026 election.

There are other distortions in Resolution 136-2025. It claims that the Election Rigging Response Act would remove safeguards. This is an overstatement. Prop 50 doesn't eliminate federal or state protections ensuring equal representation and compliance with the Voting Rights Act. It also implies that communities in El Dorado County would be split but gives no evidence of that. Finally, it doesn't clearly represent the respect embedded in Prop 50 for the California Citizens Redistricting Commission (CCRD), which indeed was created to ensure fair and impartial district boundaries. Again, Proposition 50 was introduced to neutralize a partisan mid-decade redistricting in another state. It purposely returns independent redistricting authority to CCRD after the 2030 census, and calls for a nationwide commitment to fair and impartial maps.

The intent of the Election Rigging Response Act is to provide Californians with a proportional, temporary answer to preserve balance and fairness in national representation, not to undermine independent redistricting.

I respectfully urge you <u>not</u> to approve Resolution 136-2025 given its flawed writing and unbalanced representation of the purpose and facts related to the Election Rigging Response Act. Please trust and allow El Dorado County residents to properly educate themselves and decide on Proposition 50 with their vote.
