SUBJECT: Award Bid #07-600-009 – Mailing System & Desktop Folder

Human Services/Social Services Division

Recommendation: Chief Administrative Office, Procurement and Contracts Division, recommending your Board: (1) Award Bid #07-600-009 for the purchase of one (1) mailing system and one (1) desktop folder to the low qualified bidder, Neopost Inc. of Sacramento, CA; and (2) Authorize the Purchasing Agent to issue a purchase order in the amount of \$10,879.00, including sales tax.

Reason for Recommendation: At the request of Human Services, the Procurement and Contracts Division issued an Invitation to Bid for the purchase of one (1) mailing system and one (1) desktop folder.

The new mailing system and desktop folder will replace the existing mailing system and desktop folder that processes over 50,000 pieces of mail per year. The current mailing system has become unreliable due the age and poor condition of the equipment. The department has experienced frequent costly breakdowns impacting the department's ability to post volumes of daily mail.

Eighty-six (86) Invitations to Bid were mailed; eleven (11) to local vendors. Two (2) qualified responses were received; none from local vendors. Attached is a spreadsheet for your review.

Fiscal Impact: The Department of Human Services had budgeted funds in FY 2005/06 to replace an existing mailing system. The bid was not completed in time to procure the equipment in the 2005/06 fiscal year. The Department has identified additional funding, in the amount of \$10,879.00, in fiscal year 2006/07. Funding sources are Federal, State and County.

Action to be Taken Following Approval: Following Board approval, Procurement and Contracts will issue a purchase order to Neopost Inc. of Sacramento, CA in the amount of \$10,879.00, including sales tax.
