Public Comment for BOS meeting 1/14/14, 'Shingle Springs Community Plan' item 18:

'Thank you' to the Board for scheduling the Shingle Springs presentation – your support of this kind of grassroots effort is appreciated!

The only real discussion of Community Region boundaries since the adoption of the General Plan has been on whether or not to discuss them*; there has been no actual analysis of the original boundaries since voters chose the General Plan that they thought was going to keep the county rural. The idea of waiting until the next General Plan update to address the Community Region boundaries is just not acceptable, and not just for Shingle Springs. This is a county-wide movement, and I hope the Board of Supervisors can support the communities' efforts to enact change, by:

1. Utilizing the EIR in progress to amend the Community Region boundaries throughout El Dorado County, and NOT allowing these revisions to be put off until the next General Plan update.
2. Acknowledging our infrastructure limitations [...Hwy 50!], and revising the Community Region boundaries accordingly to exclude the LDR/MDR parcels.
3. Helping county staff to adjust their mindset to the idea that we have adequate parcels for housing.

Our experience with county staff over the last 12 months has been one of non-support for Community Region boundary review. But this issue is not going away, and we need resolution. We will be back when the draft EIR is released for public comment, and will count on Supervisorial support for analysis, review, and change.
