


 - Exhibit E, is hereby amended and replaced to include label Exhibit E.
 - Exhibit B, Paragraph 2, Cost and Payment, is amended to increase the maximum compensation by Twenty-Six Thousand, Six Hundred Dollars, to a total of Sixty Thousand, Six Hundred Dollars. (\$60,600) as follows:

A. Exhibit B, Paragraph 2, Cost and Payment, is amended to increase the maximum compensation by Twenty-Four Thousand, to a total of Eighty-Four Thousand, Six Hundred Dollars. (\$84,600) as follows:
