



**RESOLUTION NO. XXX-2010**  
**OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO**

**WHEREAS**, the mandated Public Guardian Program establishes and administers conservatorships for persons and/or the estates of those who are functionally disabled, to ensure the proper care and treatment of individuals who are unable to adequately care for themselves or those who are victims of fraud and/or abuse; and

**WHEREAS**, to address considerable fiscal constraints resulting from the current economic environment, and to hold constant or reduce net County costs to the extent possible without compromising provision of critical services to the Community; and

**WHEREAS**, reassigning day-to-day oversight from a management position to a newly created Supervising Deputy Public Guardian position will result in cost containment through more efficient and cost effective operation of the Public Guardian functions; and

**WHEREAS**, it is necessary for the Board of Supervisors to approve the job specification for new classifications and to adopt the salary range and designate the bargaining unit for these classifications; and

**WHEREAS**, the County has advised the appropriate bargaining representatives of the intent to delete a 1.0 FTE vacant Program Manager-Protective Svc position and to create the job specification and the proposed salary range and bargaining unit for the new classification as set forth below; and

**WHEREAS**, in accordance with Section 601 of the Salary & Benefits Resolution #323-2001, as amended, for unrepresented employees, and Section 203 of the El Dorado County's Compensation Administration Resolution #227-84 for represented employees, a Board resolution is necessary to establish the salary range for the new classification, to become effective the first full pay period following adoption by the Board of Supervisors; and

**WHEREAS**, Resolution #158-2009 established the authorized Personnel Allocation based on the Fiscal Year 2009-2010 Adopted Budget and has been subsequently amended by action of the Board;

**BE IT RESOLVED AND ORDERED**, that the El Dorado County Board of Supervisors approves the new job specification and amends the El Dorado County Salary Schedule as set forth below; and

**BE IT FURTHER RESOLVED AND ORDERED**, that the Authorized Personnel Allocation Resolution, as amended by the following, is hereby adopted:
