BUDGET TRANSFER JUSTIFICATION AND DESCRIPTION* (will be scanned into FENIX TCM)

Department of Transportation collects fees for road permits. Larger companies that have frequent permit needs will provide a deposit for future permits to simplify their process. When a permit is pulled, the funds are transferred in operating revenues.

These funds have traditionally been deposited into a trust account but due to recent guidance from the County's external auditor, the funds were transferred into a special revenue fund. This change happened after the budget process and therefore a budget was not established. A budget transfer is necessary to allow the Department to recognize the revenue.
