## AGREEMENT FOR SERVICES #277-S1010 AMENDMENT II

### RECITALS

WHEREAS, Contractor has been engaged by County to provide electronic monitoring, and global Positioning System (GPS) tracking equipment for the Probation Department and in accordance with Agreement for Services #277-S1010, dated January 27, 2010, and Amendment I dated November 17, 2011, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to increase compensation of said Agreement, hereby amending ARTICLE III, Compensation for Services; and

**NOW THEREFORE**, the parties do hereby agree that Agreement for Services #277-S1010 shall be amended a second time as follows:

#### ARTICLE III

**Compensation for Services:** Notwithstanding any language in Exhibit "A" setting forth the "Term Worth," the total amount of this Second Amendment to Agreement #277-S1010 is hereby increased by \$84,000, the total amount of this Agreement shall not exceed \$144,318.00.

Except as herein amended, all other parts and sections of that Agreement #277-S1010 and Amendment I shall remain unchanged and in full force and effect.
