#### PROTOCOLS FOR PUBLIC COMMENT:

Matters not on the agenda may be addressed by the general public during Public Forum/Public Comment. Comments during Public Forum/Public Comment are limited to three minutes per person. The Commission reserves the right to waive said rules by a majority vote. Public Forum/Public Comment is for comment only. No action will be taken on these items unless they are scheduled on a future agenda.

Public testimony will be received on each agenda item as it is called. Individuals will have three minutes to address the Commission. At the discretion of the Commission, time to speak on an item may be extended or shortened for all speakers.

Upon completion of public comment on an agenda item, the matter shall be returned to the Commission for deliberation. Members of the public shall not be entitled to participate in that deliberation, or be present at the podium during such deliberation, except at the invitation of the Commission for a point of clarification or question by the Commission.

Individual Commission members may ask clarifying questions but will not engage in substantive dialogue with persons providing input to the Commission.

If a person providing input to the Commission creates a disruption by refusing to follow Commission guidelines, the Chair of the Commission may take the following actions:

Step 1. Request the person adhere to the Commission guidelines. If the person refuses, the Chair may ask the Clerk to turn off the speaker's microphone.

Step 2. If the disruption continues, the Chair may order a recess of the Commission meeting. Step 3. If the disruption continues, the Chair may order the removal of the person from the Commission meeting.

Hearing to consider Carson Road ARCO Canopy Extension (Design Review Permit Revision DR-R24-0001) request for to increase the existing overhead canopy and a ground-level concrete slab by 720 square feet, add one (1) additional fuel dispenser, remove 14 square feet of existing landscaping and replace with 18 square feet of landscaping, and remove and relocate one (1) air and water dispenser. The property, identified by Assessor's Parcel Number 043-550-062, consisting of 2.38 acres, is located on the south side of Carson Road, approximately 50 feet west of the intersection with the U.S. Highway 50 access ramp, in the Camino area, submitted by Nick Sandhu on behalf of Apple Hill Stations; Staff recommends the Planning Commission take the following actions:

- 1) Find the project to be Categorically Exempt pursuant to Section 15301 (e), Existing Facilities, of the CEQA) Guidelines and Section 15311 (Class 11 Accessory Structures), California Environmental Quality Act (CEQA) Guidelines;
- 2) Approve Design Review Permit Revision DR-R24-0001 based on the Findings and subject to the Conditions of Approval from the original Design Review Permit DR87-0006.

Hearing to consider: Planning and Building Department, Long Range Planning Unit, proposed amendments to Chapter 130.36 of the Zoning Ordinance (Signs) and proposed Cameron Park Sign Standards and staff recommending the Planning Commission forward the following recommendations to the Board of Supervisors:

- 1) Adopt the Addendum to the County 2015 Sign Ordinance Update Final Environmental Impact Report (FEIR), certified in July 2015 (State 2014102011) Clearinghouse No. (Legistar Attachment demonstrating that the analysis in that FEIR adequately addresses the potential physical impacts associated with implementation amendments to Zoning Ordinance Chapter 130.36 (Signs) related Cameron Park Sign Standards and both the amendments and Cameron Park Sign Standards would not trigger any of the conditions described in California Environmental Quality Act (CEQA) Guidelines Sections 15162 and 15164 calling for the preparation of a subsequent EIR or negative declaration based on the analysis prepared; and
