

## Sicuro Data Analytics, Inc.

### FIRST AMENDMENT TO AGREEMENT FOR SERVICES #8299

**THIS FIRST AMENDMENT** to that Agreement for Services #8299 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Sicuro Data Analytics, LLC, a limited Liability Company duly qualified to conduct business in the State of California, whose principal place of business is 4915 Marlin Way, Oxnard, California 93035 (hereinafter referred to as "Consultant").

### RECITALS

**WHEREAS**, Consultant has been engaged by County to assist its District Attorney's Office in providing Racial Justice Act (RJA) statistical analysis of criminal charging and outcomes pursuant to Agreement for Services #8299, dated March 5, 2024, incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

**WHEREAS**, Sicuro Data Analytics LLC incorporated at or around July 1, 2025;

**WHEREAS**, Sicuro Data Analytics LLC, now operating as Sicuro Data Analytics, Inc., has requested that County accept work under the Agreement and assign all of its rights, obligations, and liabilities to Sicuro Data Analytics, Inc.;

**WHEREAS**, Sicuro Data Analytics, Inc. acknowledges and agrees that all existing indemnity and insurance obligations shall remain in full force and effect for the duration of the Agreement for Services #8299, and as thereafter required by the Agreement;

**WHEREAS**, Sicuro Data Analytics, Inc. shall assume all Sicuro Data Analytics LLC's rights, obligations, and liabilities under the Agreement, including outstanding rights, obligations, and liabilities with providing Racial Justice Act (RJA) statistical analysis of criminal charging and outcomes;

**WHEREAS**, County will accept this First Amendment to Agreement for Services #8299 on condition that Sicuro Data Analytics, Inc. assumes and fulfills the terms and conditions of this First Amendment and the Agreement;

**NOW, THEREFORE**, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Consultant mutually agree to amend the terms of the Agreement in this First Amendment to Agreement for Services #8299 on the following terms and conditions:

- I. All references to Sicuro Data Analytics LLC, throughout the Agreement shall read Sicuro Data Analytics, Inc. Sicuro Data Analytics, Inc. assumes all rights, obligations, and liabilities for any and all services provided under this Agreement, including any services provided prior to the execution of this First Amendment.

Except as herein amended, all other parts and sections of Agreement for Services #8299 shall remain unchanged and in full force and effect.


