



RESOLUTION NO. 032-2010
OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

EL DORADO DISPOSAL SERVICES SCHEDULE OF RATES

WHEREAS, a public hearing was held on January 12, 2010 for the purpose of adjusting solid waste collections rates in Franchise Areas #1 and #2 by 3.3% increase;

WHEREAS, the resolution that was executed as part of the January 12, 2010 agenda item contained a mathematical error resulting in the detailed fee schedule to reflect rates higher than they should have been;

WHEREAS, this amended resolution corrects the mathematical error and reflects the correct rates per the Board of Supervisor action on January 12, 2010;

NOW, THEREFORE, BE IT RESOLVED that effective January 1, 2010, the following rates are adjusted for the collection of solid waste within the El Dorado Disposal Service, Inc. franchise areas:



